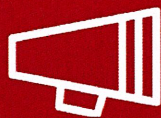

USE OF ELECTRONIC/WIRELESS COMMUNICATION DEVICES

Peck Jr.-Sr. High Students may utilize their Wireless Communication Devices (WCD) at certain times. Student WCD (phones, ipads, earbuds, smart watches, or any other devices of the sort) are not permitted in classrooms. Use of phones in classrooms and/or on school grounds or busses to record or take unsolicited photos of other students is also prohibited. **WCD in restrooms and locker rooms are strictly prohibited and will result in immediate disciplinary action.**

Grades 6-8 will be permitted to use WCD **before and after school** and during **designated passing times** listed below:

IF STUDENTS ARE BRINGING/UTILIZING WCD DURING OTHER TIMES, THE FOLLOWING CONSEQUENCES WILL BE ENFORCED:

1ST OFFENSE: WCD TAKEN TO OFFICE FOR THE DAY AND AFTER SCHOOL DETENTION ADMINISTERED.

2ND OFFENSE: WCD TAKEN TO OFFICE AND PARENTS MUST PICK UP AT THEIR CONVENIENCE AND IN SCHOOL SUSPENSION FOR THE REMAINDER OF THE DAY.

3RD OFFENSE: WCD PRIVILEGES REVOKED AND DEVICE(S) MUST BE TURNED INTO THE OFFICE DAILY EACH MORNING. IN SCHOOL SUSPENSION FOR REST OF SCHOOL DAY AND ENTIRE NEXT DAY.

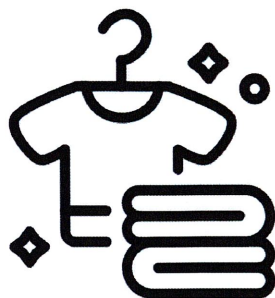
4TH OFFENSE: REVERSE SUSPENSION (PARENT JOINS STUDENT FOR ENTIRE SCHOOL DAY IN ALL CLASSES) AND A DAY IS ADDED FOR EACH ADDITIONAL OFFENSE.

STUDENT DRESS EXPECTATIONS

While fashion changes, the reason for being in school does not. Students are in school to learn. Any fashion that disrupts the educational process, presents a safety risk, or is not appropriate in the opinion of the administration will not be permitted. Our school community values an atmosphere of respect, responsibility, and readiness to learn. Students are expected to dress in a manner that reflects these values.

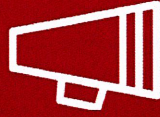
- Clothing should cover the student's torso from shoulder to mid thigh and provide adequate coverage
- Mid sections and buttocks should be covered at all times.
- Sleepwear, including pajama pants, is not considered appropriate for school.
- Hats, hoods, and other facial or head coverings aside from medical masks are not permitted.
- Footwear must be safe and suitable for daily activities.
- Any clothing with offensive, inappropriate, or disruptive images/language is not allowed.

IF STUDENTS ARE BRINGING/UTILIZING WCD DURING OTHER TIMES, THE FOLLOWING CONSEQUENCES WILL BE ENFORCED:

1ST OFFENSE: WCD TAKEN TO OFFICE FOR THE DAY AND AFTER SCHOOL DETENTION ADMINISTERED.

2ND OFFENSE: WCD TAKEN TO OFFICE AND PARENTS MUST PICK UP AT THEIR CONVENIENCE AND IN SCHOOL SUSPENSION FOR THE REMAINDER OF THE DAY.

3RD OFFENSE: WCD PRIVILEGES REVOKED AND DEVICE(S) MUST BE TURNED INTO THE OFFICE DAILY EACH MORNING. IN SCHOOL SUSPENSION FOR REST OF SCHOOL DAY AND ENTIRE NEXT DAY.

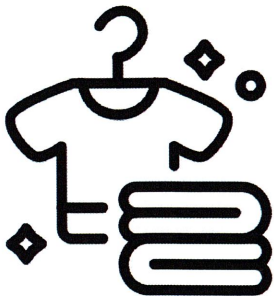
