NOW THEREFORE BE IT RESOLVED that in addition to the delegation of authority to the Superintendent in DFE (LOCAL), the Board of Denton Independent School District (DISD) also delegates to the Assistant Superintendent of Human Resources authority to accept a contract employee's resignation when the resignation is effective before the end of the school year.
