Presentations/ Recognitions Ten Denton ISD musicians earned All-State honors for the 2022-2023 school year by the Texas Music Educators Association (TMEA). TMEA is an organization of more than 12,000 school music educators dedicated to promoting excellence in music education.

These students were chosen for this prestigious honor through a competitive process held across the state at the district, region and area levels. This process begins throughout the state in auditions hosted by 33 TMEA regions. Individual musicians perform selected music for a panel of judges who rank each instrument or voice part. From this ranking, a select group of musicians advance from their region to compete against musicians from areas in eight TMEA Area competitions. The highest-ranking musicians judged at the area competition qualify to perform in a TMEA All-State music group. Thespian Award

Denton ISD has earned the Texas Thespians Premiere Communities for Theatre Education Award – a distinction that recognizes and honors school districts that provide theatre departments with the resources to achieve above standard. Only nine districts in Texas were awarded this prestigious honor out of the 1,026 eligible districts in the state.

To qualify for the Texas Thespians Premiere Communities for Theatre Education Award, Denton ISD answered detailed questions about curriculum, scheduling standards, class sizes, facilities, theatre safety, technical equipment, production elements, overall support for the theatre program and Thespian troupe involvement. Responses were verified and reviewed by Texas Theatre Education specialists.

Each year the Texas Association of School Boards (TASB) honors businesses and organizations for their support and exceptional advocacy of local schools. This state-wide honor, as part of "Stand Up for Texas Public Schools," recognizes local businesses and community organizations that partner with districts, making a difference in the lives of local public school students.

Community Spotlight

Through a partnership with Texas Woman's University, professors provide support to Denton ISD through in-service to teachers of record in dual language classrooms at 12 schools. They also support faculty members, administrators, and support staff at Denton High and Braswell High schools to effectively educate English language learners (ELLs).

Since 2014, TWU has provided a pathway for Denton ISD Education & Training graduates to complete their educational preparation and return to the district to teach through TEACH Denton. The Consortium of State Organizations for Texas Teacher Education (CSOTTE) awarded TWU & Denton ISD the Exemplary Partnership Award.

Because of the reciprocity and shared values of our organizations, Denton ISD hires more graduates of TWU than any other school district in the state of Texas.

Discussion of 2023-2024 Budget Calendar Jennifer Stewart, Executive Director of Budgeting provided the Board with an overview of the 2023-2024 Budget calendar and Budget priorities.

Discussion of Pedi Place Partnership Nicole Goodman, Director of Health Services presented an overview of the proposed partnership with Pedi-Place Medical Clinic. Ms. Goodman provided information about the Pedi Place clinic, which provides quality care to students who currently lack access to care and will allow students to return to class more quickly. This will also decrease the number of days absent due to treatable or preventable illness.

Discussion of Mid-Year Performance Update Dr. Mike Mattingly presented the Mid-Year Performance Report that is required by law and will share evidence of student learning data for the mid-year period of school year 2022-23. The data is based on formulative assessments given to students from PK through 9th grade. Cecilia Holt, Director of Early Childhood presented the Pre-K report card for 4-year-olds. Sandy Brown, Director of Elementary Curriculum presented data for the K-5 grades for primary numeracy, math, and language arts. Dr. Lisa Thibodeaux presented the data for secondary students regarding math, reading, and writing.

Discussion of 2023-2024 Open & Closed Campuses Dr. Leslie Guajardo, Director of Student Support Services presented a summary of Denton ISD's functional capacity and projected enrollment data for the 2023-2024 school year. This report will also identify current Denton ISD campuses that are open or closed to intra-district and inter-district transfers.

The objective is to routinely analyze and monitor Denton ISD's functional capacity, projected enrollment data, staffing ratios, programming needs, and other critical factors that may arise, and allow this data to guide the process for intra-district and inter-district transfers. The current designed capacity number is 740 for elementary schools, 1000 for middle schools, 2400 for DHS and RHS, and 2800 for BHS and GHS. According to board policy, an elementary building shall be closed to transfers when campus enrollment reaches 85% of the calculated maximum capacity. A secondary building shall be closed to transfers when campus enrollment reaches 90% of the calculated maximum capacity.

Based on these projected numbers, the following elementary schools will be open for transfers:

Braswell Zone- Bell, Paloma Creek;

Denton Zone- Alexander, Borman, Houston, Newton Rayzor, and WS Ryan; Guyer Zone- Adkins, Blanton, EP Rayzor, McNair, and Nelson; Ryan Zone- Ginnings, and Stephens.

The following middle schools will be open for transfers:

Braswell Zone- Cheek, Navo, and Rodriguez;

Denton Zone- Calhoun and McMath; Guyer Zone- Crownover, Harpool;

Ryan Zone- Myers.

Quarterly Growth Report 4th Qtr. 2022 Rocky Gardner, Zonda Demographics provided the Board of Trustees with a general DFW housing market, economic indicators, Denton I.S.D. residential activity and enrollment projections as of the 4th Quarter 2022 and its impact to the overall growth of the Denton ISD. In 2022, Denton ISD new home annual starts & closings remained strong in comparison to DFW overall. Average new & existing home prices in Denton ISD have more than doubled. The district has 66 actively building subdivisions with over 4,000 lots available to build on and Denton ISD has 31 future subdivisions with nearly 26,100 lots in the planning stages. Groundwork is underway on more than 3,000 lots within 18 subdivisions and Denton ISD is forecasted to enroll more than 36,600 students by 2027/28 and more than 42,400 by 2032/33.
