Mrs. Donna Ward, Assistant Superintendent of Human Resources presented list the Employment and Contract Status of Administrative Professional Personnel stating the presented list was included in their board packet. A motion was made by Ms. Gowan and seconded by Dr. Sanghi to approve the presented list which include contract status of Administrative Professional Personnel with 2-year Chapter 21 contracts ending 2024, 1-year non-certified ending 2023, and 2-year non-certified ending 2024. Mrs. Kallen Vaden introduced Mr. Matthew Tepper, an Attorney with McCreary Veselka Bragg & Allen PC Attorneys at Law. Mr. Tepper presented the annual report on

April 11, 2022 – 6:00 p.m. Board Minutes – Page 3 property tax collection activity as of December 31, 2021. As of the end of the fiscal year, June 30, 2021, the tax collection was 100.48% collected. Mr. Tepper reviewed the collection of tax levy through 12/31/21 with comparisons for the last several years, and the collection of taxes delinquent through 12/31/21 with comparisons. The cumulative percent collected was 99.5% which included 42 months of collection activity. Mrs. Vaden reported the district uses a conservative percentage of 98-98.5% for tax collections when building the budget.

**Student Services** 

Coach Scott Stewart, Athletic Director and Coach Rashonta LeBlanc, Girls' Athletic Coordinator, presented the Athletic Department Update which included the following: Updates, Programs; High school Programs; Overhauls, and Participation Numbers; Academic/Behavioral Performances; Athletic Highlights; Middle School Programs; Wildcats in the Community and Special Thanks! Some programs initiated include the Jr. Wildcats Athletic Association and Youth Wrestling, have coed coaching staff in every coed sport, new soccer stadium, competition gym upgrades, middle school soccer programs and a spring youth volleyball league. The department also served 332 fourth graders in the Learn to Swim program. A Gender Equity Plan was developed. Stats were reviewed for each sport. Athletes also participate in the community volunteering in locations such as Feed My Sheep, Seniors Christmas Dinner, Community Clean Up, Family Relocation Projects and many others.
