Every school gets one of two ratings: MET STANDARD or IMPROVEMENT REQUIRED by the Texas Education Agency. W. S. Ryan was designated Improvement *Required* during the summer of 2014. Texas Education Code Sec 39 states requirements for district and campus response, including development, hearing and approval of the Targeted Improvement Plan. This TIP was developed by teachers at the campus – primarily the Campus Leadership Team, as required by statute. Support for this process is required by statute to be given by the Campus Improvement Team, comprised of a Professional Service Provider (PSP – Dr. Sharon Long) and District Coordinator of School Improvement (DCSI – Vicki Sargent).

Discussion & Review of Financial Audit as of June 30, 2014

Carl Deaton from the audit firm Hankins, Eastup, Deaton, Tonn & Seay, P.C.A conducted the District's financial audit. The financial audit is required annually for each school district and is to be made on an organization-wide basis, including all fund types and account groups that are the accounting responsibility of the school district. The audit must be approved and submitted to the Municipal Advisory Council of Texas and the Division of School Financial Audits of TEA within 150 days following the end of the fiscal year. Mr. Deaton stated the report showed no errors and recommended no changes to the district's business practices.

Discussion of Public Service Agencies Update Lt. Kerri West, from the Corinth Police Department, Lt. Scott Lankford, from the Denton Police Department, and Cpt. Douglass Lee, from the Denton County Sheriff's Office, provided the board an overview on the district's School Resource Officers programs.

Lt. West highlighted how the SROs build relationships with the students, provide traffic control around the campus and help handle many of the emergency duties like lockdown and evacuation drills. Cpt. Lee pointed out how the office supports not just the secondary schools that they are assigned, but the feeder elementary schools with events and student programs. Lt. Scott Lankford mentioned how the SROs and Denton PD also work with students during a special summer program, support the middle school GOAL program, help with building safety audits and provide assistance with the enforcement of traffic ordinances near Denton ISD campuses.

Chad Thiessen, deputy fire marshal with the Lake Cities Fire Department, pointed out the partnerships LCFD has established with the district's campuses in Corinth and Shady Shores. Mr. Thiessen said LCFD supports safety measures, such as fire drills, but also enjoys interactions with students and staff while working events and student support programs.

Mike Penaluna, director of emergency management for the City of Denton, touched on all the various services the City of Denton works to establish with Denton ISD campuses, including an annual natural disaster drill, fire safety drills and recognitions of students on their knowledge and understanding of safety measures and procedures.

Institute of Museum & Library Services Grant Report Donna Kearley, Library Services Coordinator provided the Board with information regarding a grant she is working on with UNT, TWU and the City of Denton Public Library. Denton Inquiry 4 Lifelong Learning (DI4LL) is a groundbreaking project with multiple learning space partners in Denton, Texas. Our long range plan is to produce a replicable model of a Pre-K-20 research initiative that is adaptable by other educational groups for improving student performance in research and critical thinking.

The purpose of this grant is to write a vertically aligned curriculum for inquiry skills from Pre-Kindergarten through Grade 20 (Graduate-level dissertations) which according to a review of the literature has not been done before. Our partners in the grant are UNT Libraries, UNT SLIS, TWU Libraries, TWU SLIS, and the Denton Public Library.
