Dear Parents and Community Members:

On the reverse side of this letter is a Notice regarding CCCCSD's Adequate Yearly Progress (AYP) status for 2012. The District as a whole and each campus individually will be engaged in improvement efforts all year designed to meet AYP performance targets according to standards drafted in 2001. Students and families at OMS and OHS have received similar Notices at the start of school.

Almost 70% of Texas Public School campuses and districts are engaged in similar required improvement processes. Texas Commissioner of Education Michael Williams has recently filed for waivers of No Child Left Behind accountability for Texas beginning in 2013-2014, but for now, Texas is one of two states that must continue to follow school improvement processes outlined in NCLB.

Crockett County schools are continuously engaged in analyzing and improving student academic performance. We feel very good about early indicators and scores from newly implemented STAAR testing this past Spring. However, we will always have a higher bar to shoot for, and NCLB / AYP standards are important to us.

TO PARENTS OF STUDENTS ATTENDING Crockett County Schools:

Within three months after being identified for improvement, an LEA must develop or revise its district improvement plan in consultation with parents, school staff, and others. The district improvement plan must meet certain requirements, one of which is implementing strategies to promote effective parental involvement in the district. The district will be implementing the following activities to address the reasons the district has been identified for district improvement: regular benchmarking of student performance; increased tutoring for students related to specific performance gaps; and professional development targeted at strengthening instructional practice in low performance areas.

You may become involved in addressing the reasons the district is identified for improvement by assisting in the following ways: visits with campus and district leaders to maintain awareness of instructional progress; involvement at campus as a parent volunteer, PTO member or site-based decision-making team member; attendance at campus and district site-based-decision making meetings; or attendance at meetings of the Board of Trustees where information is shared regularly about academic goals and performance.
