Presentations/ Recognitions The College Board honored 130 Denton ISD high school students with distinctions for 2018, according to their annual list of recipients who are named Advanced Placement Scholars. Tonight, the Board of Trustees honored AP Scholar students from Guyer High School.

Kara Brown addressed the Board regarding the new Woodrow Wilson Elementary construction and the close proximity of their homes to Wilson.

Discussion & Review of Woodrow Wilson Elementary Schematic Design Terry Hoyle, Stantec Architects presented the schematic design for the new Woodrow Wilson Elementary campus. The Mission of Woodrow Wilson's new school building will create a welcoming environment for the community. It will foster collaboration and discovery in a safe and calm environment. The school shall be organized in grade level pods, and each pod will have dedicated collaboration spaces with convenient connection to the outdoors from every grade level pod. The campus will have 50% solar energy and comparable sustainable strategies to prototype.

Quarterly Growth Report – 4th Quarter 2018 Bob Templeton, Templeton Demographics presented the 2018 4th Quarter Growth Report to the committee. Denton ISD started and closed over 2,200 homes in 2018. Mr. Smith stated Denton's unemployment rate is below 3% and most of the growth in home sales over the last five years was seen in the Ryan and Union Park Elementary zones. Ryan, Savannah, and Union Park Elementary zones accounted for approximately 60% of the total district

closings in the last 12 months. The total number of home sales within Denton ISD has increased by 1,540 sales, or 41%, since 2010. Denton ISD has more than 3,800 lots available to build on and the District has nearly 30,000 planned future lots and of those future lots, groundwork is underway on more than 4,570 lots. The District can expect an increase of nearly 3,700 students during the next five years.
