4. DISCUSSION/CONSIDERATION

4.1 Forecast 5

Tony Jerisha of Forecast 5 presented on analytics for Illinois public schools. Forecast 5 is a software development and data analysis company affiliated by common ownership with PMA Financial Network. He talked about strategic and operational ways schools can use analytics and how data can come from national, state, survey and local sources. Several examples were shown through a PowerPoint presentation on different kinds of data that can be analyzed.

We are now starting to pull interim data throughout the year. We can envision the district having a tool to see how they look and being able to bring predictive analysis to you. Several tools and charts were demonstrated to show how information can be pulled in. We are currently in a transition period and we hope that when the transition is complete we will be able to give more detail than before.

Discussion, comments, questions: Will you get to the point that you are consulting? (At some point we may. The obstacle is that we want to do more with the tools than we are able to currently.) Can you show us ACT scores and the cost per pupil? (Absolutely, the line graph shows composite score and you can narrow down by county. You can compare to other districts. There is also the comparison variable that will allow you to compare by low income.) Is it possible to show data on cost per student on instruction? ISAT scores can be broken down in many ways and with the changes in test scores data can look stronger at times. Can you show some surveys we were working on with units? (Yes. We work closely with groups to show data they are looking for. Data can be entered quickly.) When you want real time data you could do a survey and all districts could enter their information that you would have access to. Within 5Share you could be connected to several groups.

4.2 Treasurer's Report Format

At the last meeting you were given different report formats to look over. We are waiting to hear which way you want to go. Let's carry this over to the next meeting. We all have different ideas of what we want to see.

Discussion, comments, questions: We don't need anything extensive, but maybe some bullet points. I would like to see our reserves and operational side each month. I would like us to separate our operating and non-operating funds. We are only seeing a snapshot of today so would like to see more. There was one sample report that did a great job of laying out operational funds, as well as text. I would like to see a summary of bills being paid. We are just looking for more detail.
