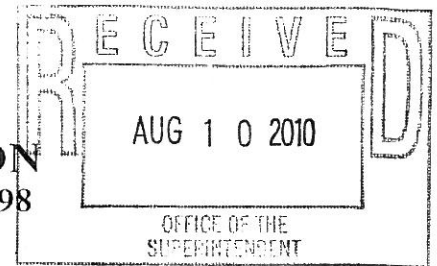
If your district is interested in entering into an agreement or if you are not interested in permitting our students to attend your schools, please reply to this letter so that we could demonstrate due diligence.

The federal No Child Left Behind Act of 2001, enacted in January 2002, requires any school that has failed to make "adequate yearly progress (AYP)" on the State assessments for two consecutive years (i.e. is in "school improvement status") to offer parents the opportunity to choose to send their children to a higher performing school (Public School Choice). Berwyn North School District 98, specifically Lincoln Middle School, Prairie Oak Elementary School and Karel Havlicek Elementary School must offer Public School Choice.

It is the intent of Berwyn North School District 98 to meet the obligations under the federal law. Therefore, we are determining if any of our neighboring school districts would be interested in entering into an intergovernmental agreement to serve the "most in need" students from Lincoln Middle School, Prairie Oak School and Karel Havlicek School. If your district has a school that is higher performing, (i.e. not in school improvement status and with a higher composite score and willing to accept students), please notify me immediately. We recognize that it will be the obligation of Berwyn North School District 98 to provide transportation and tuition costs consistent with state and federal law as defined in an intergovernmental agreement.

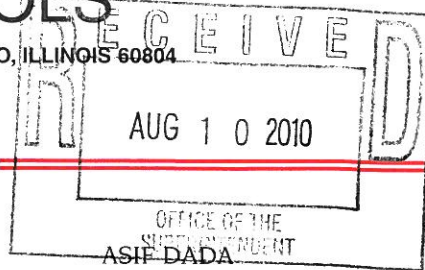

The federal *No Child Left Behind Act of 2001*, enacted in January 2002, requires any school that has failed to make "adequate yearly progress" on the State assessments for two consecutive years (i.e., is in "school improvement status") to offer parents the opportunity to choose to send their children to a higher performing school. Cicero School District has thirteen schools that are in school improvement status, and while we do have schools that are higher performing, placement at those schools is not an option as they are at capacity based on our collective bargaining agreement.

It is the intent of the Cicero School District to meet all of its obligations under federal law. Therefore, we are determining if any of our neighboring school districts would be interested in entering into an intergovernmental agreement to serve our students from these thirteen schools. If your district has a school that is higher performing, i.e., not in school improvement and with a higher composite score than any of the thirteen schools, and willing to accept students, please notify me immediately. We recognize that it will be the obligation of Cicero School District to provide transportation and tuition costs consistent with state and federal law and defined in an intergovernmental agreement.
