# Waterville-Elysian-Morristown December Pivot

November 12, 2020 \* Work Session

#### **Background Information**

In our weekly meetings with Le Sueur County Public Health we have been closely watching and monitoring case counts. At WEM we have been complimented many times for our mitigation strategies and attention to detail in efforts to maintain current learning models, it is being suggested that we pivot learning models as a proactive and necessary measure.

We understand that changing learning models is challenging for our students, families and staff we are committed to being in a more restrictive model temporarily and for as brief of time as possible. Public health is suggesting using more restrictive models until at least after winter break. We will transitions back to a less restrictive model as soon as we are able based on numbers.

## Recommended policy options based on 14-day case rate range

Elementary hybrid, Middle/high school distance	30 to less than 50

PreK-6th Grade first day in Hybrid (currently in a modified version)

Starting 11/30 Grades PreK-12 Distance Learning

We will transition back to a less restrictive learning model as soon as possible.

Changes from our original distant learning plan include 15 minutes between classes compared to 10 minutes. This will give students a little longer screen break and allow teachers five additional minutes to transition within their virtual links.

While instructional time is 35 minutes, the additional 15 minutes between classes allows for 50 minutes total, still being within contractual prep time.

Teachers will continue to report to district buildings to the extent possible.

Attendance expectations will continue to be administered by teachers each hour. Study Halls will not require students to be logged on throughout the entire hour, but teachers will be available for additional help. If a student is falling behind, has been recommended by SAT or is identified as needing additional support they will be asked to stay online during their study hall and work through systems of support with their study hall teacher.

#### Virtual expectations of students includes:

- -Appropriate use of technology
- -Appropriate language and communication with staff and fellow classmates
- -Timely entrance into virtual classes and maintain presence throughout instruction
- -Virtual behavior follows district codes of conduct

## 7-12th Grade Counseling Support

WEM will continue working with Counseling Services of Southern Minnesota.

School Counselors will continue to reach out to students, network with families and develop channels to best serve and assist students.

2:15-2:45 p.m. is a daily time where counseling groups will meet. Counselors can meet virtually 1:1 or in small group.

Counselors/student success coordinator will assist students struggling with organization. The planner board will continue to be used by staff.

#### 7-12th Grade Academic Support

Administration will continue to pull "F" Lists weekly and work with staff to follow-up on students who are are not in passing range. Outreach to parents will also continue from administration, school counselor/student success coordinator and teachers.

2:15-2:45 p.m. will allow for an additional study hall/instructional support for students. Students may be assigned this time to report for additional help and gain resources of support.

WEM will provide further educational support to students on need base. This may include students in the building for academic support for partial days, single hours, etc.

## **School Age Care**

School Age Care (SAC) will continue to be offered before and after school to school age children, 5-12 years old.

Prioritization of Children of Families Working in Critical Sectors stemming from Executive Order 20-94

#### School Age Care

Equitable and affordable school-age child care programs are essential to support working families and provide enrichment and care for students. Care for school-aged children, especially those children of workers in critical sectors, will continue to be crucial for frontline workers to continue to confront the pandemic. The state will continue to work with child care providers, school-age programs, schools, and all other child care settings to prioritize this need.

What will this look like for WEM School Age Childcare

- Smaller group sizes
- Designated pick up and drop off locations
- Individual supplies, and limiting opportunities for shared materials
- Increased cleaning of classroom spaces and materials prior to and after use
- Social distancing strategies will be practiced

## **Facility Use**

- MSHSL is continuing with fall activities as planned.
- The MSHSL is collecting some data tomorrow regarding schools and what model they are currently operating in and if they are allowing sports activities.
- Updated MSHSL guidance for winter activities tomorrow.

#### **Other Considerations**

Food service will be offered with pick-up times TBA for grades K-12. Food service director, Nancy Culhane, will provide further directives on the distribution process.

Transportation will change and shift. Further discussion will be done with director, Travis Huber.

Para support may change. Paraprofessionals may be assigned duties with students and SPED staff not in the building they were assigned to begin the year.
