## **BACKGROUND INFORMATION:**

The District is seeking a qualified provider(s) to provide Physical Therapy Services for the 2025-26 School Year. Sealed Proposals were received by the district on June 12 at 2 p.m. The committee evaluated the submitted bids on June 16. The District has utilized Accelerate Contract Therapy Service for the past 3 years. However, the two possible one-year renewals

have expired and the district is going out to bid for due diligence.
