D.1. Communications

- Most recent survey, the majority of the voters believed in the package we are presenting.
- Reduces overcrowding, positive and compelling message.
- 55% is the golden number, we have never seen this in our community
- Targets-likely to shift towards a yes vote- Current parents, younger voters (especially age 30-39) young Independents (especially men) and older women.
- Gaps persist based on gender, age, educational attainment and homeownership, women are more likely to vote yes than men. Under age 50 more likely to vote yes, age 70+ more likely to vote no.
- Support increases among now divided Republicans and numbers improve amoung voters with kids.
- Community Outreach-In person and different locations, turnout was ok, but did have a lot of 1:1 conversations.FB live with Superintendent Carpenter and VC Wheeler reached about 1000 people
- Completed Outreach Events-
- Identifying and supplying resources to supporters
- Developing materials and compiling data for the next phase of communication
