SY2021-22 enrollment Average Daily Membership (ADM) was 23.82 which is +1.1 ADM's higher than the previous SY2020-21.

Fiscal Quarter 4:

Expenditures for FY 22 are at 98%, difference of \$80,949.43 with Joint Sports Bill yet outstanding which will close the 2% gap putting us over budget.

- We have received 83% of our budgeted General Fund 01 Revenue. Approximately 10% should be received by October.
- State Educational Record View and Submission (SERVS) system has a quarterly draw/withdraw schedule for the COVID grants and expenses accrued at the end of the school year have a delayed draw. Once each grant is expensed in the Uniform Financial Accounting and Reporting Standards (UFARS), then our school district's funds are withdrawn. The following grants will be drawn and received this month in July and moved (back) into FY 22:
