On October 1, 2019, a fifth donation totaling \$61,200 was received from Bio ridge Pharmaceutical Company being offered by Mylan's EPIPENS4SCHOOLS Program. Health Services Department received 2-Pak (Epinephrine) Auto-Injectors 0.3mg and EpiPenJr 2-Pak (Epinephrine) Auto-Injectors 0.15mg. These EpiPens 2-Pak are worth \$600.00 each and the district received a total of 51 boxes of pediatric Epipens and 51 boxes of adult Epipens or 102 boxes. These Epi-pens will be distributed to all campuses to provide emergency care during a severe allergic reaction (Anaphylaxis) which can be life threatening.
