WORK SESSION: The Board discussed building projects and the student attendance initiative.

REGULAR SESSION: President Smith called the regular session to order at 6:59 p.m. Mr. Busenbark offered prayer. Mr. Bench led the Pledge of Allegiance to the Flag of the United States of America.

RECOGNITION: The Extra Degree award was presented to Melissa Rasmussen and Idawna Defa for their exceptional contributions to student success.

ADMINISTRATIVE REPORTS: The Board reported on their observations while visiting schools. Darin Jenkins reported on the goals of Tabiona School. The goals are to help all students to achieve, ensure all students are reading on grade level, and personal reading goals for every student.

OPEN TIME: At 7:25 p.m. President Smith opened the meeting for those who signed up for public comment. Sarah Simpson asked about a pre-school for Tabiona. Janalee Goodrich commented that grant resources have not yet funded that addition. Madilyn Hamilton expressed concerns for the adequacy of the facilities in Tabiona. Jan Rhoades inquired what plans were in place for the school. Clifford Murray commented on the many new requirements placed on schools by legislators and meeting the needs of students. Logan Gines commented on the needs for facilities at the school. Mr. Thacker noted the important partnership with the community that created the community center. Mr. Bench noted the need to work together. Lee Gines noted the new Tabiona gymnasium is one of the best in 1A, but felt Tabiona was being left behind. Mary McClusky asked about school funding and expressed opposition to pre-school. Krissy Runolfson asked about the proposed amendment to the constitution. Ms. Wells noted concerns about the amendment and encouraged people to get out and vote. President Smith closed open time at 8:07 p.m.

ACTION ITEMS:

- Policy 2nd Reading: 3.0411.10 Personal Leave & 3.0411.11 Professional Leave Superintendent Young noted final clarifications to the policy. Mr. Bench moved to approve. Ms. Wells seconded; passed unanimously.
- 2. <u>Policy 2nd Reading: 6.0210.09 Convicted Sex Offenders on School Property</u> Superintendent Young noted the practicality of implementing the policy for administrators and when the different levels of care were

necessary. Mr. Busenbark moved to approve with the additional clarifications. Mr. Thacker seconded; passed unanimously.

- <u>Policy 3rd Reading: 1.0110.01 Open Time</u> Superintendent Young noted the changes recommended from last meeting and the addition of clarifying paragraphs. Ms. Wells moved to approve the policy. Mr. Busenbark seconded; passed unanimously.
- <u>Travel Requests: UHS Cross Country</u> Superintendent Young noted three phenomenal runners had requested permission to attend competition in Phoenix and then nationals in Portland if they qualify. Mr. Bench moved to approve. Mr. Thacker seconded; passed unanimously. <u>National CTE Conference</u> Jim Freston requested to attend. Mr. Bench moved to approve. Ms. Wells seconded; passed unanimously.
- 5. <u>Buildings</u> Superintendent Young reported the Duchesne High was finishing a little more slowly to make sure it's done right. Altamont shops has a new supervisor with better progress and hoping to close in as soon as possible. Plans for Altamont Elementary and High School gymnasium were nearing completion. Mr. Thacker moved to proceed with the entire Altamont project and to start the process of contractor selection. Mr. Bench seconded; passed unanimously.
- 6. <u>Fraud Risk Questionnaire</u> After review Mr. Bench moved to approve. Mr. Thacker seconded; passed unanimously.
