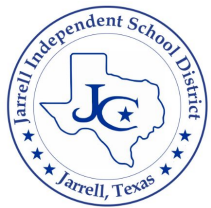

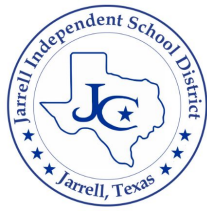
# Policy EFB (Local) - Alt
