Section 3 of the Student Attendance Handbook states:

- (1) The student is participating in an activity that is approved by the local board of school trustees and is under the direction of a member of the professional or paraprofessional staff of the school district, or an adjunct staff member who:
- (A) has a minimum of a bachelor's degree; and
- (B) is academically eligible for participation in the Teacher Retirement System of Texas.

<u>Jim Wells</u> County requests the agents listed on the enclosed Adjunct Faculty Agreement be awarded adjunct staff member status for the period of time indicated on the agreement.

On behalf of the 4-H members of Jim Wells County, we hereby also respectfully request that the 4-H organization, by the attached resolution, be sanctioned as an extracurricular activity.
