WHEREAS, the Groesbeck Independent School District (the "District" or "GISD") undertaking capital improvements, renovations, and repairs to District facilities and other improvements as approved by the voters of the District (the "Groesbeck ISD 2025 Bond Projects" a/k/a "Groesbeck ISD Facility Projects"); and

WHEREAS, the Board of Trustees of Groesbeck Independent School District (the "Board") has previously determined that that Construction Manager-At-Risk ("CMAR") is the delivery method that provides the best value and is in the best interests of the District for the Groesbeck ISD 2025 Bond Projects; and

WHEREAS, the Board has previously delegated authority to the District's Superintendent of Schools or his designee the authority to develop any procurement and solicitation documents, as necessary per Texas law, including establishing criteria and weight to be given to such criteria and to publish notice and advertisement to request proposals, bids, or qualifications, as applicable for a CMAR; and

WHEREAS, in keeping with that authority, the Superintendent of Schools solicited proposals for a CMAR through a one-step process in accordance with Texas law, received proposals and ranked the proposals based on the published weighted criteria in conjunction with the proposal evaluation committee; and

WHEREAS, the order of ranking as approved by the proposal evaluation committee has been provided to the Board at this duly noticed and called meeting for the Board's consideration.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF GROESBECK INDEPENDENT SCHOOL DISTRICT AS FOLLOWS:

1. It is found that the foregoing recitals are true and correct and are hereby adopted as findings of fact by the Board of Trustees of Groesbeck Independent School District.
