Lodging in Puerto Rico has been carefully chosen with the goal of accommodating our groups safely and comfortably. We stay in a home base in a quiet town outside of San Juan for much of the stay. Students will be rooming in small groups, separated by gender. When single rooms are available, we will make every effort to provide each chaperone with their own individual room. If this is a concern for your group, please call the Global Works office to discuss alternate lodging options (which may result in an additional charge).

CUSTOM TRANSPORTATION

Our primary mode of transportation is through private chartered "busetas" or mini-buses. We have been working with reputable companies for over 15 years.

COMMUNICATION

Global Works provides 24/7 emergency contact service for the families of all participants. Families will be able to stay connected to participants by reading updates and viewing photos posted on the trip blog. Participants will be able to call home periodically during the program.

SAFETY AND SECURITY

Since our inception in 1990, health and safety have been our first and foremost criteria in choosing our travel locations. We take a preventative approach to minimize the inherent risks of travel, avoiding areas that do not meet our standards. First aid kits are on all programs and leaders are minimally certified in First Aid and CPR. We have an Emergency Action Plan detailing medical care and evacuation plans for each location. Each location is visited and scouted prior to the trip by trip leaders to ensure a positive, safe, and healthy experience for our participants. Our Home Office staff and leaders continue to attend risk management conferences, medical training, and our risk management systems and training programs are seen as a model for the industry.

Deposits are fully refundable for 30 days following your group's deposit due date and when the trip does not meet the minimum participant requirements. For tuition protection, the Program Cancellation and Interruption Protection Plan is available for purchase. This plan allows for a refund of the tuition less deposit under the policy's specified conditions. Full tuition and Program Cancellation and Interruption Protection Plan fees must be paid by tuition due date as financial protection begins at the time your first tuition payment is received and ends on the last day of the program. Please note that airfare is not considered part of the tuition, cannot be refunded, and is not covered by the Program Cancellation and Interruption Protection Plan (PIP).

Global Works is not required to provide any refund for late arrival, early withdrawal, or dismissal with cause. If a participant withdraws for personal reasons or a medical emergency or injury anytime after the tuition balance due date, refunds will be made at the sole discretion of Global Works. AIRFARE

Due to fluctuations in domestic and international airfare, Global Works does not include airfare in the tuition. Global Works contracts with group consolidators to ensure the most competitive prices possible. Airfare quotes are available upon request.

INSURANCE

Participants are required to have emergency evacuation and medical coverage while on the program. Global Works offers an optional policy through AXIS. AXIS Medical and Evacuation Insurance details are provided on the group's Login Page for a complete explanation of coverage. Additional coverage may be purchased by participants at their own expense.

Global Works does not offer flight or travel insurance to cover flight delay, flight cancellation, or airport related expenses. We recommend that your group purchases this type of coverage from an outside provider.

ITINERARY

Global Works reserves the right to make changes in the itinerary when deemed necessary for safety and logistics. On certain holidays some attractions might be closed. We will offer a similar activity or refund you the value of the cancelled event. We will provide all travel details, including hotel names and your Global Works Director's name, 30-60 days prior to departure. Flight times, airlines, and hotel information are subject to change.

PASSPORTS & VISAS

It is each participant's responsibility to obtain a valid passport and, if necessary, a visa for entry. If a participant is not a US citizen, it is the participant's responsibility to determine whether a visa is necessary for entry into your destination country. Non- U.S. citizens must contact the appropriate embassies and consulates to inquire about any visa requirements for all countries to be visited. (U.S. citizens may wish to do this as well.) LOSS OF POSSESSION

Global Works does not cover the personal property and equipment of participants; parents should check with their own insurance policy to insure that their child's personal property and equipment is covered against loss, theft, or damage.

RULES & REGULATIONS

If a participant acts in a way which endangers or is injurious to himself/herself, people of the host country, other participants on the trip, or generally conducts himself/herself in a way that is disruptive to the trip, we reserve the right to send the participant home without refund. Possession or use of alcohol, tobacco, or un-prescribed controlled substances, as well as engaging in sexual activity, exclusive relationships, and unauthorized absence from the group, are violations of our rules. Possession or use of any weapons is strictly prohibited. Participants sent home early or who choose to leave for any reason, including sickness, personal emergencies or injury, will be responsible for all medical costs, and will absorb all costs related to travel associated with an unscheduled departure. There will be no tuition refund for participants who teave the program early for any reason. Failure to disclose fully any information regarding the participant, which results in an inappropriate placement in a Global Work program, is cause for dismissal without tuition refund. Global Works will dismiss, without tuition refund and at parent(s) expense, any participant who disrupts the group or who violates the Participant Agreement.
