- I. SUPERINTENDENT'S REPORT
  - A. Recognitions Keevin O'Neill: Mr. O'Neill stated that Ben Gangloff and Savanah McDowell were named National Merit finalists.
  - B. Student Enrollment Count Day February 8, 2017: Superintendent Glaes reported that the District is down approximately three students from first count.
  - C. Legislative Report: Supt. Glaes stated that Governor Snyder's budget recommendation was encouraging. The budget now goes to the legislature.
  - D. Important Dates: Supt. Glaes referenced the District Solo and Ensemble last week where the high school scored five "ones".
  - E. Days/Hours Update: The District has utilized three snow days and have three remaining.

- A. Business and Finance Report Steve Goss
  - 1. Budget Progress Report for the Month Ending January 31, 2017: Asst. Supt. Goss presented the budget progress report for January, 2017 showing total revenues of \$11,417,573; total expenditures of \$11,937,489 and deficiency of revenues over expenditures of \$(519,916).
  - 2. Bond Update: Mr. Goss reviewed the bond timeline. Mr. Goss also discussed the procedures for using the door entry system.
- B. Instructional Report Charlie Glaes
  - 1. Curriculum Review Gail Van Daff: Mrs. Van Daff explained that a curriculum process was necessary with the implementation of the common core and new standards. Mrs. Van Daff reviewed the process and the timeframe for the review and discussed the first draft of the seven year cycle.
  - 2. Middle School Report Matt VanDussen: Mr. VanDussen thanked the Board for allowing Dennis Kirby and him to lead the building and told a bit about who they are.
    - a. Recognition of Officer Henry Kite: Mr. VanDussen shared six characteristics were representative of Officer Henry Kite and thanked him

for all he does at the Middle School.

- b. "Moving Forward Together": Mr. VanDussen shared the great things that are happening at VMS including the systems that are in place to support student learning, Middle School goals, building a positive climate for the staff and students, and building student and building leadership teams.
