Dr. Nohelty:

Thank you very much for your call this afternoon. As I mentioned, I had sent a couple of previous FOIA requests to Sirlena Thomas Conway and Dr. Eric Kellogg but was uncertain whether these were the proper individuals. I appreciate your confirming that you will receive the request, so please regard this as my initial inquiry.

I am a freelance researcher based in Milwaukee and am gathering background information for a non-commercial study of law firms representing special purpose districts. Pursuant to the Illinois Freedom of Information Act, I am emailing to request the following:

1) Copies of all legal services engagement agreements between the district and its outside legal counsel for any lawyer or firm performing services for the district in the past 12 months.

2) Copies of all legal services invoices received by District 152 in the period of May through July, 2012 from any attorneys or law firms providing legal services to the District. If invoices from this period are not available, please provide the invoices from the most recent three-month period. I recognize that these may require some redacting of confidential references.
