For collection, we require only a table for completion of paperwork and restroom facilities. We do recommend having water and cups available for students that are unable to provide a specimen.
- **On-site breath alcohol testing utilizing DOT-approved equipment for reasonable suspicion or for events such as prom and homecoming.** Students can be tested entering and/or leaving the event, ensuring that participants are not 'under the influence' and therefore pose no risk to themselves or anyone else.
- **Drug testing program gives students the perfect reason to say 'NO' to drugs and resist the temptation to give in to peer pressure.**
- **We utilize only *SAMHSA-certified* laboratories that specialize in this type of testing and provide you with the strictest chain-of-custody procedures. We do not typically utilize *clinical* laboratories that normally do not adhere to the same protocols as *SAMHSA-certified* laboratories and have other testing priorities.**
