#### I. SUPERINTENDENT'S REPORT

## A. Recognitions:

- National School Lunch Week: October 12-16 "Wild about school lunch!" -Maureen Ouvry: Mrs. Ouvry informed the Board about school lunch week and that a Dietetic Intern from WMU is working with the district.
- Michigan Principal's Month Charlie Glaes: Supt. Glaes read the Governor's Proclamation explaining why principals are special and important to student success. The Board acknowledged and thanked the principals for their dedication.

- B. October 7, 2015 Count Figures: The count came in at 2,669.97. K-12 was up 15 students compared to last year. The WAY program dropped from 102 to 83, due in part to the large number of recent graduates plus a continued growth in the number of alternative education offerings in Kalamazoo. The total count is down 3.51 FTE from last October.
- C. Local Housing Assistance Fund Millage: Supt. Glaes requested approval of a resolution in support of the Local Housing Assistance Fund Millage which will be on the November ballot. The millage would create a fund which would provide temporary financial housing assistance and support services that lays the groundwork for ongoing housing stability for homeless families with school-age children throughout Kalamazoo County. The millage will provide assistance for an estimated 100 families annually. There are families within Vicksburg Community Schools who could use this support, and Mr. Glaes urged the Board to approve the resolution later on the agenda.
- D. Legislative Update: Supt. Glaes reported there is movement on 3<sup>rd</sup> grade reading in the legislature. Board members were asked to review packet information and keep in touch with legislators.
- E. Important Dates: Guests were directed to the listing of important dates including the MSBOA Marching Band Festival.

## II. REPORT AND PUBLIC INQUIRY

- A. Community Education Annual Report Tonya Nash: Ms. Nash highlighted the 30<sup>th</sup> Year of the Vicksburg Tumbling and Dance Program which has approximately 400 student participants each year. Dawn Simpson and three students displayed dance costumes. Alyssa Thompson, Indian Lake GSRP Program Lead Teacher, was also present to explain student scores and growth comparisons in our expanded (three classrooms, five full days per week) GSRP program.
- B. Business and Finance Report Steve Goss
  - 1. Budget Report: Asst. Supt. Goss reported that five bids were received for State Aid Borrowing. RFPs were sent to as many banks as possible. The award was based on the lowest bid which and went to Macatawa Bank at 0.93% for \$850,000 for six months.
    - Asst. Supt. Goss reviewed the budget progress report for September, 2015 showing total revenues of \$1,410,674; total expenditures of \$3,003,166; and deficiency of revenues over expenditures of -\$1,592,492.
  - 2. Bond Update: Mr. Goss reported that most of the bond items in this series have been completed. The shift has focused to next year's projects. We will be issuing next round of bonds (series 2 or 3) next summer.
- C. **Be a Superhero!** Tobey Instructional Report Mike Barwegen: Mr. Barwegen presented Tobey's Strategic Plan: Ensuring All Students Learn, Building a Collaborative Culture, and Establishing a Focus on Results.
