I. CALL TO ORDER: Chairman Peggy Katkocin called the meeting to order at 7:00 p.m.

V. PUBLIC PARTICIPATION

Selectman Khris Hall spoke as a private citizen and encouraged taxpayers to vote during the budget referendum this Saturday, May 5th. She spoke specifically about money in the budget for school safety.

Consolidated School Principal Rob Spino announced that Art Teacher Marie Flanagan will be retiring from Consolidated School. He noted that instead of replacing her with another Art teacher that he would like to hire an additional Physical Education teacher. The students currently have gym once a week and Art twice a week. Hiring a Physical Education teacher instead of an Art teacher will allow for gym to be twice a week and Art to be once a week. Mr. Spino spoke of the importance of both Art and gym but spoke of the reasons for adding an additional Physical Education class each week.

Pat Bower spoke of a possible computer data security breach in the system.

First Selectman Pat Del Monaco encouraged everyone to vote at the budget referendum this Saturday, May 5th at MHHS between the hours of 10 a.m. and 8 p.m. She asked that everyone try to understand the process in order to make an informed decision.

VI. BOARD AND ADMINISTRATIVE COMMUNICATIONS

A. <u>Chairman's Report</u> - Chairman Peggy Katkocin noted that she received notification about negotiations with the New Fairfield Education Association. The commencement date for the negotiations must be by August 4, 2018. Mediation date if necessary is September 23rd and Arbitration is October 18th. Generally two or three BOE members participate in this process. Mrs. Katkocin asked the BOE members to let her know by the next Board meeting if they are interested in participating.

Peggy Katkocin noted the BOF has been asking for information and metrics on programs that have been funded in recent years in order to determine the return on investment. She suggested giving presentations to the BOF to showcase the many aspects of the New Fairfield Schools.

B. <u>Superintendent's Report</u> - Dr. Alicia Roy spoke of the following:

• The Smarter Balanced Assessment is this month. She noted how important the data collected from these tests is and encouraged all students to take these assessments.

• Met with the Culture and Climate Committee and they recommended inviting students that have done well and achieved to the BOE meetings for recognition.

• Six high school students received national recognition on the National Spanish Exam.

• The Middle School had 56 students take the National Spanish Exam. Of the 56 students, 29 received national recognition.

• Consolidated School students celebrated earning 100 paw prints for their PBIS program. "Fancy Day" was held as a reward.

• National College Decision Day was May 1st. The high school had 18 student athletes that committed to play at the college level.

- The Major Minors at MHHS sang the National Anthem at the Mets Game on May 1st.
- The high school had their spring concert on May 2nd.
- Noted that she has met with the Administration regarding a possible anonymous reporting program.
