SUPERINTENDENT'S REPORT

During the Superintendent's Report, Mrs. Jenkins shared that three students, Divnoor, Roark, and Anika, attended the Triple I Joint Conference before Thanksgiving Break with Board of Education members and D70 administrators to share their student voice and learn how boards of education work. The students, who are members of the Superintendent's Student Leadership Advisory Board, will all take turns at board meetings this year to offer their thoughts on various topics to increase student voice in education.

At Adler Park School, Mrs. Jenkins also talked about students using manipulatives when doing math and creating art pieces after learning about Keith Haring. At Butterfield School, students went to a nearby theatre to see Cinderella and enjoyed a schoolwide assembly playing games for good behavior. At Copeland Manor School, students enhanced their American Civilization knowledge by playing games, celebrating World Kindness Day, reading a book, and then creating artwork afterward to show their understanding of the topic. Highland Middle School students were honored in a Buzzworthy Breakfast for all their good work. At Rockland School,

students made artwork for World Kindness Day, listened to a Mystery Reader, and played games to learn tricky words.

APPROVAL OF FINAL 2024 TAX LEVY

Board Report 8.1 sought approval for the Final 2024 Tax Levy. Per the Illinois Property Tax Code, a Tentative Levy Estimate is to be presented at least 20 days prior to the adoption of a school district's Final Aggregate Levy. If the aggregate estimate is more than 105% of the prior year, a public hearing must be held on the district's Final Aggregate Levy before it can be adopted. Additionally, a notification of the public hearing must be published no more than 14 days nor less than 7 days prior to the date of the public hearing. See below for a detailed timeline. For tax year 2024 (collectible in 2025), school districts must submit their levies to the applicable County Clerk's office no later than the last Tuesday of December.

Levy Estimate Presented to and Approved by BOE November 18th, Truth in Taxation Notice in Daily Herald December 1st, Final 2024 Tax Levy Hearing December 9th, Final 2024 Tax Levy Adoption December 9th, Filing of 2024 Final Tax Levy with the Lake County Clerk No later than December 31st.

The older section of Rockland Elementary School was built in 1926 and is in need of renovations including plaster wall repair/painting and new flooring in classrooms and adjacent hallways/offices.

The Board has \$50,000 set aside in the Operations and Maintenance Fund to meet their local obligation.
