#### SCHOOLYARD

The Board continued the discussion from April 10, 2012 on the possibility of replacing the playground surfaces with rubberized materials.

O'Neill reported that the playground upgrades are included in the capital plan. The Facilities committee is refining the plan and she believes that the district will find the additional funds needed to upgrade the playground surfaces to the rubberized materials. Other budget lines that could be considered to finance this project were discussed.

The Board secretary left the meeting at 6:20 p.m.

Although not all Board members were in agreement, it was noted that the rubberized surfaces on the playgrounds will improve accessibility, durability, equity and will add to the quality of each building.

Administration was asked to move forward with this process.

Dr. Roberts reported that the district will be getting a grant to cover the International Baccalaureate trip to Shaker Heights, Ohio.
