Quarterly Position Report August 31, 2023



Yields on U.S. Treasury bonds rose during the three-month period ending August 31 with the 3-year note leading the way with an increase of 50 basis points. The U.S. equity markets continued to rally as the SP 500 index rose by nearly 8%. The Federal Reserve (Fed) did not raise the target rate at the June Federal Open Market Committee (FOMC) meeting; it was the first meeting that the target rate was not increased since January 2022. Many considered it a "hawkish pause" as the members indicated that this was not the end of the tightening cycle. The Fed then raised the target rate by 0.25% to a range of 5.25-5.50% at the July 26 FOMC meeting. market has continued to be resilient, but some cracks in the jobs market have emerged recently. The JOLTS (Job Openings and Labor Turnover Survey) was weaker than expected. The unemployment rate rose by 0.3% to 3.8% in August; however, part of that increase was due to a rise in the labor force participation rate. The market has discounted a future rate hike, despite the Fed indicating that they will raise the target if needed. The next FOMC meeting is September 19-20.
