A. Superintendent Dave Bernhardson

Thank you to Activities Director Will Short and our Simley leadership team for sharing information about Simley High School this evening.

Board Member Larsen - Hearing directly from our students is always a highlight. Beyond scores,

our focus is on relationships and team building. Congratulations to Girls Swim team member Mia on breaking a long-standing school record.

Board Member Niemioja - The Fall Activities presentation was meaningful to me. Hearing what each team, along with our theatre and band students, shared shows how many ways our students are having their cups filled.

Board Member Dukes - I attended the boys soccer tournament and was so excited for them. Listening to the activities comments made me think about my own coaches and the relationships we built. You can clearly hear those same strong relationships forming between our students and their coaches today. I also had the chance to visit a school recently, and it's evident that the work happening across our buildings is centered on putting students first through the 199 Way.

Board Member Pierson - It can be challenging to lose a leader you have grown accustomed to, and I heard similar reflections from high school students about new teachers and coaches. For example, the swim team shared how they had to adjust to a different style of coaching and leadership, a skill that is valuable not only in sports but in life. High school administrators also emphasized the importance of helping students develop core life skills to navigate changes. When I asked the American Indian Education Coordinator what had surprised her most about our district, she said it was how kind, welcoming, and inclusive everyone is.

Board Member Warrick - It was wonderful to hear that our American Indian Education Coordinator feels our district is kind and welcoming. I am also very excited about the upcoming *Light Up the Island* event in a couple of weeks. Thank you to the students who took the time tonight to share their experiences with us.

Board Member Klingner - I am super proud of the students every year. Every time we have students come talk it makes me proud and you can hear how proud they are of each other. Activities have transitions of seniors leaving that creates other students to step up and lead. I was at the swim meet this past weekend and as I was there I saw Will Short at the event, and it reminded me how our community adults consistently show up for our kids, dedicated to supporting their success.

Board Member Lounsberry - How amazing is it that we have former students who care so deeply about this community that they choose to come back and work here! We heard from staff members Jack Ryan and Cullen Berg, who are helping middle schoolers feel comfortable as they transition to high school. Their approach is so thoughtful and relationship-driven. I truly believe that when people feel deeply cared for, they can settle in, think more clearly, and tap into their creativity.
