*For purposes of this Agreement (including this Task Request), the term "Architect" shall mean "Engineer" with all required licenses in the State of Texas.

Project:

Killeen ISD 2026 HVAC Life Cycle Replacements

Solely with regard to the Project defined herein, this Task Request modifies the existing Standard Form of Agreement Between Owner and Architect for Architectural Services on a Task Request Basis, AIA Document B101-2017, as modified by Owner, dated November 3, 2025 (the "Agreement"). Except as modified in this Task Request, all terms and provisions of the Agreement shall remain in effect. As stated, the modifications noted in this Task Request shall only be applicable to the specific Project described herein.

SCOPE OF SERVICES AND SCHEDULE

§1.1 Section 1.1, including subsections 1.1.1 and 1.1.2, is hereby amended to include the following:

Architect shall perform engineering services for the Killeen Independent School District's 2026 HVAC Life Cycle Replacements ("Project") as more fully described in the proposal attached as Exhibit 1, which is attached for reference purposes only. In case of any conflict between Exhibit 1 and the Agreement or this Task Request, the Agreement and this Task Request shall control,

provided that any services set forth in Exhibit 1 that are not otherwise described in the Agreement shall be included in the scope.

§1.1.4 Section 1.1.4 is hereby amended as follows:

§11.1 Section 11.1 is hereby amended as follows:



RE: Professional Services Agreement Between EMA Engineering & Consulting and Killeen Independent School District

EMA Engineering & Consulting, Inc. hereby submits the following proposal for professional services to Killeen Independent School District for the **2026 HVAC Life Cycle Replacement Projects** located in Killeen, Texas. EMA's services for this project will include:

- Team approach and attitude (e.g., Owner, Engineers, Contractors).
- Initial meetings and reviews with Owner to obtain scope of work, define work packages, budgets, priorities, phasing, scheduling, problems, maintenance needs, facility needs, standardization, etc.
- Obtain any specific Owner requirements. Meet with Owner's maintenance and facility personnel.
- Conduct site visits at Ira Cross and Montague Village Elementary Schools to verify existing RTU and controls conditions and gather information for design due diligence.
- Evaluate replacement options for RTUs and building control systems to align with Owner standards, energy efficiency goals, and summer 2026 construction schedule.
- Evaluate scope of work with budgets, schedules, etc., and coordinate with Owner.
- Work with Owner to develop specific scope of work by phase, priority, and budget. Define work packages.
- Prepare design plans, specifications, and construction documents for the RTU and controls replacement projects. Conduct coordination/review meetings.
- Complete final plans and specifications for construction.
- Assist in the bidding and procurement process for both campuses, with the option for combined award
 if advantageous to the Owner.
- Provide construction administration services, including submittal reviews, RFIs, site visits, and project closeout documentation.

Our total fee is a fixed fee of \$245,000. The fee will broken up as follows:

Killeen ISD - 2026 HVAC Renovations to Ira Cross ES \$120,000 Killeen ISD - 2026 HVAC Renovations to Montague Village ES \$125,000

This fee includes professional liability insurance, travel expenses, per diem, telephone, Revit/CAD drafting, and digital submission of all design documents. All services will be performed with a standard of care customary for our profession and region. Both parties agree to resolve any disputes through mediation before pursuing other legal remedies.
