The Danville School District requests a waiver from A.C.A. 6-10-106, which establishes the first allowable day of class as the Monday of the week that contains August 19th. This specific waiver seeks to allow the Danville School District to set their first day of class for the 2024-2025 school year as Wednesday, August 14, 2024.

This waiver would also allow the district to start school "no earlier than August 13th" for the subsequent four school years.

#### The advantages of this waiver are:

- This waiver will give greater assurance of school ending in late May rather than extending into June.
- Beginning school earlier automatically results in more days of instruction prior to spring testing. More
  days of instruction will result in higher test scores,
- Due to our student demographics, this start date would allow many of our students to get back into school earlier where they would be assured two meals during school hours.
- Moving the start date would have a positive impact on student attendance

The granting of this waiver does not affect any other law, rule or procedure. The school year will remain the same length. It simply allows a district to continue with a school calendar that has similar start dates to the current school calendar.

  - The district will monitor student assessment results and student attendance data related to the earlier start of the school year by no more than five days.

BE IT FURTHER RESOLVED that the Board of Directors expresses its support for the waiver request and acknowledges the importance of flexibility in addressing the unique needs and circumstances of the district.

This resolution shall take effect immediately upon adoption.




