# ADSIS (PARA) INTERVENTIONIST EMPLOYMENT CONTRACT SOUTH KOOCHICHING-RAINY RIVER SCHOOL DISTRICT #363

The purpose of this agreement is to set forth the basic agreement covering rate of pay, hours of work, and conditions of employment. This position is uniquely independent of any other School District work group or organized union and shall be dependent on the ADSIS grant funds. **This agreement is between ISD #363 and Gracie Arhart**.

# I. Period of Time Covered by this Agreement

This contract is for one year beginning August 21, 2023 and terminating on May 28, 2024. The ADSIS Para Interventionist shall work on days school is in session for the licensed staff. During the school year, the ADSIS Para Interventionist workday shall begin at 8 AM and end at 3:30PM with a 30-minute duty free lunch period.

## II. Supervision:

The immediate supervisor of the ADSIS Interventionist shall be the Northome School Principal. The District Superintendent will also have responsibilities associated with the supervision of this position.

# III. Job Duties Summary:

The purpose of the program is to provide Reading/Math Interventions for students in grade K through grade 8, as identified and assigned to the ADSIS program by the building principal. These identified students are significantly underachieving in Reading compared to their peers. They are at risk of failure and/or being placed into special education services. In part, these students may also exhibit social emotional or behavioral disorders, placing them further at risk and in need of positive interventions. The ADSIS Para Interventionist will administer Reading/Math interventions to increase academic achievement in Reading/Math and provide behavioral support services to promote more healthy life choices. The ADSIS Para Interventionist will provide strategies and organizational supports for students participating within the program. Collaboration with administrators, special education teachers, classroom teachers and outside agencies is also necessary to create a seamless educational program for the identified students.

## IV. Benefits:

1. Health and Hospitalization Insurance Coverage

The School District will pay \$530 per month of the cost of single or individual coverage. Any additional cost of the premium shall be borne by the ADSIS Para Interventionist and paid by payroll deduction. The School District shall pay the cost for family coverage up to a maximum cost to the school district of eight hundred and sixty eight (\$735) per month. Any additional cost of the premium shall be borne by the ADSIS Para interventionist and paid by payroll deduction.

## 2. Life Insurance

The District will contribute up to \$62.00 per year toward the premium of individual life insurance coverage. Any additional cost of the premium shall be borne by the ADSIS Para Interventionist and paid by payroll deduction.

## 3. Compensation for Expenses

Upon <u>prior approval</u> of the Superintendent and in connection to the assigned duties of this position, the ADSIS Para Interventionist will be compensated for such incurred expenses as mileage, meals and lodging at the rates set by the School Board.

#### 4. Sick Leave

The ADSIS Para Interventionist shall earn 12 days of sick leave. Sick leave may be used according to M.S.181.9413. Unused sick leave shall not accumulate into the next year.

# 5. Personal Leave

The ADSIS Interventionist shall have two (2) paid personal leave days per contract year. Unused personal leave days will not carry over into the next year. The ADSIS Interventionist can submit a voucher at the end of the year to receive reimbursement for any unused personal leave. Reimbursement shall be at a rate of \$65 per 7 hour days.

#### 6. Other Leaves

The ADSIS Para Interventionist shall qualify for Jury Duty, Funeral Leave and Child Care Leave as found in the Classified contract.

# V. Salary:

The ADSIS Para Interventionist shall be paid based on an hourly rate of \$23.16 for the 23-24 school year.

## VI. Evaluation

During the period of this agreement, then ADSIS Para Interventionist will be evaluated at least annually by the Superintendent or Principal.

# VII. Entire Agreement and Modification

The terms of this agreement constitutes the entire agreement and understanding between the School District and Employee. Neither party has relied on any oral or written promises or inducements in entering into this agreement. This agreement supersedes any and all prior oral or written agreements and understandings relating to the Employee's employment with the School District. This agreement may be modified or amended only by a written amendment signed by both parties.

#### VIII. Contract Termination

This contract may be terminated by the ADSIS Para Interventionist, at any time, with a one month written notice. This contract will be reviewed for renewal or nonrenewal at the end of the contract date.

The ADSIS Para Interventionist shall faithfully perform the services prescribed by the School Board whether or not such services are specifically described in this agreement, abide by the rules, regulations and policies as established by the School Board and the State of Minnesota. Failure to do so will be grounds for termination by the School District.

This agreement shall be effective only upon signature of the chairman and clerk of the School Board after authorization for such signature has been taken by the School Board with appropriate action recorded in its minutes.
