1.0 GENERAL FUNCTIONS

CALL TO ORDER

2.0 MOMENT OF SILENCE

President Lori Ann Garza led the board members and the public in a prayer.

3.0 PLEDGE OF ALLEGIANCE/TEXAS FLAG PLEDGE

Ms. Priscilla Benavides, Robert Driscoll Elementary School Teacher, and some of her third-grade students led the board members and the public in the Pledge of Allegiance and the Texas Flag Pledge.

4.0 PUBLIC PARTICIPATION

There were no comments from the public.

5.0 SUPERINTENDENT'S CELEBRATION(S)

Dr. Jose Moreno congratulated the RECHS Lady Pickers and their coaches for a job well done and presented a video of the highlights of their basketball season. The girls ranked 16th out of 1,150 school districts in the State of Texas. Coach Roy Williams reported that this school year, they stopped other teams by playing defense. Without the defense, they would not have been able to go the four rounds. He thanked the administration and board members for their support. The girls went 9-0 in the district and made the playoffs, won the first playoff game in the district, and then made regionals. The twenty-three wins and only three losses was a great accomplishment for the girls and every single one of them made the Academic All-District Team. He has been doing this for forty-two years, and he had never seen the support that they received from the parents and community. He thanked everyone because it takes everyone to do their part. He recognized each member of the team and their achievements. The students and coaches were presented with certificates of appreciation and a goody bag.

Dr. Jose Moreno announced that a Board and Superintendent Goals Workshop would be held on Saturday, March 20, 2021, at 8:30 a.m., at Hattie Martin Elementary Cafeteria.

6B LOTSPEICH ELEMENTARY SCHOOL EDUCATIONAL RESULTS PARTNERSHIP HONOR ROLL SCHOOL – 2019-2020

Dr. Jose Moreno presented a plaque to Mrs. Vanessa Peterson and her lead teachers from Lotspeich Elementary School, for receiving the Educational Results Partnership Honor Roll School for the 2019-2020 school year, for their continuous achievement in closing the gap.

PRESENTATION BY ROBSTOWN ISD SOCIAL SERVICES DEPARTMENT Dr. Jose Moreno announced that this month was Social Work Awareness Recognition Month. Ms. Nataline Hall reported that her department works with students and families to empower them to be resilience and to turn the risk factors into protective factors. They were able to serve students during the pandemic and freeze by letting them know that they were there to support and serve them. If necessary, they will visit students at home to provide food, clothing, drop-off and pick up packets, drop off devices, and make sure that the students are safe. They also support students that cannot focus on academics because of social or emotional things going

on at home. She reviewed the following three practice areas of social work: Micro, Mezzo, and Macro, the student/family district and administration support, projects, initiatives and collaborations, and professionalism of social workers. The very first year they were able to serve 127 students, 505 students were served the next academic school year, and so far they have already served 264 students this school year.

6D PRESENTATION FROM RISD EDUCATION FOUNDATION

Dr. Rumaldo Juarez reported that the annual banquet scheduled for April 2020 was cancelled. The foundation has one new board member, Mr. Hector Lopez. Mr. Julio Rangel has been selected to serve as the new Vice-President for the Development Committee. The foundations current budget balance is \$63,788.00. Since they were not able to hold the annual banquet, they held the Red and White Day of Giving. A total of \$10,443 was raised and a total of \$20,000 will be allocated for this school year's grant awards for teachers. The ten applicants that were submitted were all approved for a total of \$18,838.00. They were able to award three scholarships (\$1000 each), to teachers pursuing their advanced degree. Also, they were able to award fourteen \$100 gift cards to first-year new teachers to the school district. The total awards for this school year were a total of \$23,226.

6E MONTHLY ACADEMIC SCORE CARD

Dr. Jose Moreno presented and reviewed the school district's discipline report for the RECHS, Seale Jr. High School, and Ortiz Intermediate by reporting periods. He also reviewed the school district's intersession counts, the number of students that were attending face to face, and the ADA per campus. The intersession before the Spring Break was being provided for the sole purpose for students to make-up days and to give school district the ability to provide additional intervention. The high school held a Senior Saturday the week before the intersession for parents to receive an update on their child. Every single parent and student had the opportunity to speak to a counselor before they left and 95% of the seniors showed up. A total of 127 students showed up for the intersession.

6F LIST OF BILLS

Mrs. Vanessa Riggs thanked the Board for the opportunity to serve the students and community. She reported that the total expenditures in February were \$4,440,491.85. The list of bills included the bond payments which are due in February and August.

6G FINANCIAL STATEMENT REPORT

Mrs. Vanessa Riggs reported that the revenues collected for the month of February was \$17,131.311, and the total expenditures for the month were

at \$11,976,399. Function 61 was the only one over 50% and all of the other functions were under the 50% level. The tax collections thus far were at \$8,059,554.32, which was around 80.25% of taxes collected.

6H SUPERINTENDENT UPDATE(S)

Dr. Jose Moreno reported that Amistad had a total of 200 vaccines to administer, and they would be using the school district as a host site. The school district's employees would have the first choice. A survey will be sent out to the school district's employees to find out how many employees have been vaccinated and how many have not. The shot was a personal choice. He reminded everyone that they would be having the ribbon cutting ceremony for the baseball field on Wednesday, March 23, 2021, at 3:30 p.m. On Wednesday, they will be starting the Athletic Director interviews. A total of thirty-five applicants were received, and they were able to bring it down to ten applicants. Out of the ten applicants, they ended up with seven applicants. The interview will be for one hour and out of the seven, he will bring two or three to the Board. The Finance Committee is working on a plan for the sponsors for the scoreboard, and they should be getting two additional sponsors for the scoreboard. He recommended requesting proposals for the batting cages to get the best proposal. He will be meeting with the committee to discuss this item further. The school district will be adding bleachers at the softball field, and the money would come out of the Building Fund. The bleachers are going to costs anywhere from \$36,000 to \$37,000. As soon as the Booster Clubs get organized, all of the concession stands should be able to start operating. Mrs. Maribel Trevino will be getting together with a group of parents to finalize some of the options for the prom. He has been approached by the Water District to see if the school district was interested in having them fill some of the parking lot potholes. He would look into the liability of this item. Also, he informed the Board that when they first started to pay for the WFI data service the school district was being charged around \$8500 for 280 hot spots and they have gone back to the regular price of \$16,000 instead of the \$8500 for the hot spots. The new education rate is \$5800 and they have adjusted the first three months, and they are waiting on them to adjust the rest of the months.

DISCUSS RISD REOPENING OF SCHOOL PLAN 5A

> Dr. Jose Moreno announced that most school districts are starting to open even though the Texas Education Agency has given them the option to remain remote for students that wish to stay remote for the remaining of the school year. He was prepared to send out a survey to parents, to make an effort for students to come back. The school district was losing out by not bringing the students back so he asked for their input. A discussion was held on this item.
