Re: Student and Facility Fee Schedule – School Year 2026-2027

Date: February 23, 2026

Introduction

Each year at this time, the District establishes the fee schedule for the upcoming school year. Setting these fees in the winter allows the District to accurately project revenue sources and provides families with ample time to plan for the following year's expenses.

Situation

The District categorizes revenue into two primary fee sources: **Student Fees** and **Facility Fees**. For the upcoming school year, the District recommendation focuses on maintaining stability for families while adjusting for specific rising operational costs.

Proposed Adjustments:

- **Student Registration:** No increase.
- **Ancillary Fees:** No increases to lock, graduation, or athletic fees.
- **Facility Rentals:** No change to the current rate structure.
- **Transportation:** A fee increase is recommended to align with the rising operational costs of student transport.
- **New:** The addition of a Blended Preschool Tuition.

Fee Requirements & Deadlines

To ensure fiscal responsibility and timely collection of revenue, the following requirements remain in effect:

- **Payment Deadline:** All student registration fees must be paid in full by **September 1**.
- **Late Fees:** A \$25 late payment fee will be applied to any invoice that is 60 days past due.
- **Hardship Provisions:** The District remains committed to accessibility. Parents unable to pay fees due to financial hardship may complete a "Fee Waiver Request" form, available on the District website.

Included with this memo is a detailed schedule providing an itemized breakdown of the proposed structure for both student and facility fees.

Recommendation

The administration is recommending that the Board of Education approve the fees for the 2026-2027 school year as presented.

PRIORITIES AND GROUP CLASSIFICATION FOR COMMUNITY USE OF SCHOOL FACILITIES

In scheduling the use of Bloomingdale School District 13's school facilities and properties, activities associated with the district's regular customary curriculum and extracurricular programs shall have priority over the activities of any other group/organization/individual.

For the purposes of approving and scheduling requests, the following categories of user groups are hereby established.

Group I School Sponsored Groups of School District 13
Bloomingdale Park District
Bloomingdale Fire Protection District, Bloomingdale Police Department
Employee associations
Approved student groups, booster clubs, parent-teacher organizations
Approved teacher activities
Approved intergovernmental agreements and leases

Group II Non-Profit Groups (*Child-Oriented)
Boy/Girl Scout and similar groups
Religious groups
Cultural groups
Recreational groups

*Child-oriented shall be defined as the age group of children who are normally served by the educational program of District 13; i.e., preschool through 8th grade. A percent of the participating children shall live within the boundaries of School District 13. See Rules and Regulations: Indoor Facilities, page 8; Outdoor Facilities, page 9.

Group III Non-Profit Groups (**Adult-Oriented)
Civic groups
Governmental entities
Other taxing bodies within District 13 boundaries
Religious groups

**Adult-oriented shall be defined as any group whose target audience is adult and not primarily students in preschool through 8th grade. 90% of the participating adults shall live within the boundaries of School District 13.

Group IV Profit Groups - Charging Fees
Commercial groups for recreational purposes with participants residing within District 13 boundaries

Group V Board Approved Leases or Partnerships (requires Board authorization for building use)
Commercial groups for recreational purposes with participants residing outside District 13 boundaries
