RESOLUTION FOR THE HONORABLE DISMISSAL  
OF CERTAIN PART-TIME EDUCATIONAL SUPPORT PERSONNEL

WHEREAS, the Board of Education of Bloomingdale School District No. 13, DuPage County, Illinois, has made a decision to decrease the number of part-time educational support personnel employees employed thereby and/or discontinue some particular type of educational support service, pursuant to Section 10-23.5 of The School Code of Illinois (105 ILCS 5/10-23.5); and

WHEREAS, the hereinafter named employees are part-time educational support personnel employees in the school district; and

WHEREAS, the Board of Education must first dismiss all part-time educational support personnel employees with the shorter length of continuing service with the school district within the respective category of position; and

WHEREAS, the Board of Education has determined that the hereinafter named part-time educational support personnel employees shall be honorably dismissed within the designated category of position effective as of the end of the 2018-2019 school term.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Bloomingdale School District No. 13, DuPage County, Illinois, as follows:

Section 1: That the following part-time educational support personnel employees are hereby honorably dismissed within the designated category of position effective as of the end of the 2018-2019 school term, and not reemployed for the 2019-2020 school term by reason of the decision of the Board of Education to decrease the number of part-time educational support personnel employees employed thereby and/or discontinue some particular type of part-time educational support service:
