Re: Long-range Facilities Plan Change Order Approval Information

Change Order #2, Bid #1159-2R (Contract #0420) – Stretar Masonry and Concrete, Inc. Change Order increase to revise the height of one window; omit burnished finish on block wall; add

Leny 71. Leid

8" block and mechanical openings; add an opening in the CMU wall in boiler room; install 8" CMU in lieu of 12" along stair and revisions to exterior masonry due to decreased louver sizes; build a jog in CMU wall at storage room
