The meeting was called to order by the President, and upon the roll being called, Mark
Grosso the President, and the following members of the Board of Education were physically
present at said location:

The following members were allowed by a majority of the members of the Board of
Education in accordance with and to the extent allowed by rules adopted by the Board of

No member was not permitted to attend the meeting by video or audio conference.
The following members were absent and did not participate in the meeting in any manner
or to any extent whatsoever:
The President announced that the Board of Education would next consider the
adoption of a resolution providing for the partial abatement of taxes heretofore levied for tax
year 2017 (payable 2018) for the purpose of paying principal and interest on the School District's
Local Government Program Revenue Bonds, Series 2001-A (Capital Appreciation Bonds Series
2001A).
Whereupon Member presented and the Secretary read by title a
resolution as follows, a copy of which was provided to each member of the Board of Education
prior to said meeting and to everyone in attendance at said meeting who requested a copy:

BOARD OF EDUCATION OF GENEVA COMMUNITY UNIT SCHOOL DISTRICT NO. 304 KANE COUNTY, ILLINOIS

RESOLUTION providing for the partial abatement of taxes heretofore levied for tax year 2017 (payable 2018) for the payment of principal and interest on the Local Government Program Revenue Bonds, Series 2001-A (Capital Appreciation Bonds Series 2001A), of Community Unit School District Number 304, Kane County, Illinois.

WHEREAS, on the 29th day of May, 2001, the Board of Education (the "School Board") of Community Unit School District Number 304, Kane County, Illinois (the "District"), adopted a resolution providing for the issue of not to exceed \$19,499,905.15 Local Government Program Revenue Bonds, Series 2001-A (Capital Appreciation Bonds Series 2001A) (the "2001A Bonds") of the District and for the levy of a direct annual tax sufficient to pay the principal and interest on the 2001A Bonds (the "2001A Bond Resolution"); and

WHEREAS, on the 5th day of June, 2001, a duly certified copy of the 2001A Bond Resolution was filed in the office of the County Clerk of Kane County, Illinois (the "County Clerk"); and

WHEREAS, the 2001A Bond Resolution called for the levy of a direct tax upon all the taxable property within the District sufficient to produce the sum of \$11,005,000 for 2017 (payable 2018) the payment of principal and interest on the 2001A Bonds up to and including January 1, 2019; and

WHEREAS, on the 29th day of May, 2001, responsive to authority contained in the 2001A Bond Resolution, a contract for the purchase of \$19,499,905.15 Capital Appreciation Bonds Series 2001A (the "Bonds") was awarded by then-President of the Board and then-Business Manager, as the "Designated Representatives" of the District under the 2001A Bond Resolution; and

WHEREAS, on the 26th day of September, 2017, the District filed with the County Clerk of the County of Kane a Certificate of Reduction of Taxes that abated the amount previously levied for the Bonds for tax year 2017 by \$7,320,000, which reduced the amount levied for tax year 2017 to \$3,685,000; and

WHEREAS, the District now has on hand in its Debt Service fund the amount of \$1,200,165, which is available to pay a portion of the aforesaid principal and interest on the 2001A Bonds due on or before January 1, 2019; and

WHEREAS, the Board finds and determines that it is in the best interests of the District that the \$1,200,165 on hand and available in the Debt Service fund of the District be used to pay a portion of the aforesaid principal and interest on the 2001A Bonds due on or before January 1, 2019; and

WHEREAS, as a direct result thereof, it is in the best interests of the District that part, but not all, of the 2017 taxes (payable 2018) heretofore levied for the payment of principal and interest on the 2001A Bonds be abated.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Education of Community Unit School District Number 304, Kane County, Illinois, as follows:

Section 1. That the School Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true, and correct and does incorporate them into this Resolution by this reference.

Section 2. That the \$1,200,165 on hand and available in the Debt Service fund of the District be used to pay a portion of the aforesaid principal and interest on the 2001A Bonds due on or before January 1, 2019.

Section 3. That part, but not all, of the taxes heretofore levied for 2017 (payable 2018) for the payment of principal and interest on the 2001A Bonds are hereby abated, as follows:

and the County Clerk of the County of Kane is hereby directed to reduce the amount of taxes levied and to be extended for the District's 2001A Bonds for tax year 2017 (payable 2018) by the amount of \$1,200,165 to the amount of \$2,484,835.

Section 4. That this Resolution shall affect taxes only for the 2017 tax year (payable 2018) only to the extent that they relate to the 2001A Bonds.

Section 5. That the President and Secretary of the Board are hereby authorized and directed to execute a true and correct copy of this Resolution and the Administration of the District is hereby authorized and directed to file duly-certified copies of this Resolution in the office of the County Clerk of the County of Kane, Illinois.

Section 6. That this Resolution shall be in full force and effect forthwith upon its adoption.
