Presentations/ Recognitions

Each year the College Board recognizes National Merit Scholars for their performance on college-level exams and, while there is no monetary gift associated with the award, their scores most often earn students course credit that helps with tuition at some of the country's most prestigious universities.

The National Merit Scholarship program identifies the country's academic elite and is based on a student's performance on the Preliminary Scholastic Aptitude Test (PSAT). Denton ISD has produced 42 National Merit Semifinalist in the past 16 years.

Two members of Guyer High School's Class of 2019 has been chosen out of 1.6 million total entrants to be a semi-finalist scholar in the National Merit Scholarship Program for this year's graduating class. Seniors Gabriel Lee and Sarah Spivey join an elite pool of just 7,600 National Merit Semifinalists in the entire country.

More than 34,000 students throughout the nation are recognized for their exceptional academic promise and deemed commended scholars. The district's Class of 2018 had 21 commended scholars.

The district also had three students who received recognition as National Hispanic Scholars or National Achievement Scholars.

Ami Ware, librarian at Providence Elementary was recognized for this month's Educator Spotlight.

Two Denton ISD graduates and local restaurant owners, John Williams (Oak Street) and Corey Bobbitt (Komodo Loco), could not stand the thought of students not being able to pay off their lunch balances. The Mac'n Cheese Festival of Denton was born and became the hottest ticket in town. After posting online, the event's tickets sold out within days and \$4,500 was raised to pay-off student balances across the district.

1st Open Forum

Ed Soak addressed the Board about gas wells located near some Denton ISD schools.

David Martin addressed the Board about the new Denton High School. He lives in the neighborhood west of the new Denton High School location. They would like to see a larger area between the homes and the campus.

Willie Hudspeth addressed the Board and stated that in the past 44 years there has not been an African American Head football coach. Also feels there has not been an African American or Hispanic Educator spotlighted.

Discussion of Financial Audit Report Year Ended June 30, 2018 Carl Deaton from the audit firm Hankins, Eastup, Deaton, Tonn & Seay, P.C.A conducted the District's financial audit. The financial audit is required annually for each school district and is to be made on an organization-wide basis, including all fund types and account groups that are the accounting responsibility of the school district. The audit must be approved and submitted to the Municipal Advisory Council of Texas and the Division of School Financial Audits of TEA within 150 days following the end of the fiscal year. Mr. Deaton stated the report showed no errors and recommended no changes to the district's business practices.

Discussion of Denton High School Schematic Sloan Harris, VLK Architects present the proposed schematic of the new Denton High School. The project will build upon and incorporate the many strong traditions of Denton High School while creating new learning and teaching opportunities that will lead to greater opportunities for the students supporting the district's vision. The reconstruction of Denton High School will serve 2,400 students at a new site providing next generation learning environments and alignment with the Denton ISD standard of high school campuses. The design was developed by students, parents, teachers, administrators and community leaders who participated with VLK Architects at Dr. Curtis Ramsey Professional Development Center. Working in teams, they created the conceptual framework for the design being presented.

Discussion of Attendance Boundary Rezoning Jeff Russell, Area Superintendent presented the proposal of the rezoning for the Union Park Elementary school. The proposal will bring equitable student ratios and reduce overcrowding for Bell, Paloma Creek and Union Park Elementary schools. The goal is to keep all elementary schools at 740 students or less and to rezone families as few times as possible.

Discussion of Replacement Cycle for District Technology Dwight Goodwin, Director of Instructional Technology presented the proposed replacement cycle in specific targeted areas. The goal is to have a five-year life cycle refresh plan for updating campus computer labs, libraries, PDC training units, and teacher PCs for the purpose of supporting the 4C's and enhancing the innovative learning spaces.

Discussion of Review of Investment Strategies Vicki Garcia, Executive Director for Administrative Service provided an overview to the Board of Trustees of the current investment strategies and presented options for investing bond funds. Approved investment instruments are T-Bills/Fed Funds, Certificates of deposit and share certificates, fully collateralized repurchase agreements, No-load money market mutual funds and no-load mutual funds, guaranteed investment contract as an investment vehicle for bond proceeds and Public funds investment pools.

Jeff Robert, Hilltop Securities presented the information on the Flexible repurchase agreements are authorized investments under Texas Government Code §2256.011 and have been in use since before the Texas Public Funds Investment Act's inception in 1987. Flex Repos" are collateralized investment agreements and they offer the ability to fully collateralize deposits @ 103% with treasury & agency securities. You can withdraw funds as needed and earn a fixed rate of return.

Property Tax Report 2017-2018 Mark Burroughs, from Sawko & Burroughs Attorneys provided the Board of Trustees with a property tax activity report for the Tax Year 2017-2018. The 2017-2018 collections year brought current-year delinquent collections to an all-time high of 99.60% collection. Less than one million dollars (\$959,382) of the entire 2017 adjusted levy of \$245,737,977 remains to be collected.

Head Start Annual 644 Financial Compliance Cathi Robbins provided the Board of Trustees a summary of the Ann Windle School for Young Children (AWSYC) Head Start Administrative Requirements and Standards from section 644 of the Head Start Act. Annually, each Head Start Agency must report the following information

from the most recently concluded fiscal year:

- The total amount of public and private funds received and the amount from each source.
- An explanation of budgetary expenditures and proposed budget for the fiscal year.
- The results of the most recent review of the financial audit.

AWSYC is funded by a Federal Grant in the amount of \$1,335,886. The grant requires a local match of 20% or \$333,971. A total from all sources during the 2017-2018 school year for matching dollars is \$1,047,659. The award for 2017-2018 reflects a COLA (cost of living adjustment) increase over the previous year in the amount of \$13,017.
