The enclosed Declaration Letter is for districts that will be issuing less than \$10 million in tax exempt debt during the calendar year that is required by Pinal County's servicing bank. If the letter is not returned or if your district will be issuing more than \$10 million in tax exempt debt, the district will be charged a higher rate of interest when borrowing against the line of credit.

Please have the form signed by the Board of Directors and returned by December 13th, 2013 to ensure the viability of your line of credit.

LETTER OF DECLARATION

In compliance with the Tax Reform Act of 1986, the Governing Board (the "Governing Board") of the SAN MANUEL/MAMMOTH USD #8 (the "Borrower") hereby requests that Wells Fargo Bank, National Association ("Wells Fargo") to issue a line of credit (the "Credit Line") as directed by the Pinal County Treasurer's Office. The line of credit is designated as qualified tax-exempt obligations pursuant to Section 265 of the Internal Revenue Code of 1986.

We are reasonably sure that the SAN MANUEL/MAMMOTH USD #8 Will issue LESS than \$10 million in total debt during the 2014 calendar year. Will issue MORE than \$10 million in total debt during the 2014 calendar year. Such debt will include all tax-exempt bonds, lease-purchase agreements, registered warrants, and any other form of tax-exempt debt.
