4.3 Ensure Strategic Alignment of Resources

BACKGROUND INFORMATION:

For Bond 2023 Projects, the District is seeking a qualified HVAC Engineering Firm to conduct Testing and Balancing of the new HVAC systems at T.M. Clark Elementary, High School Cafeteria/Culinary Renovations, High School Fine Arts/Band Hall Renovations, and the

Operations & Family Resource Center Facility. Testing and balancing is Testing, adjusting and balancing is the process of evaluating temperature and environmental control systems to ensure they're heating or cooling according to design specifications and at the equipment's best level of efficiency. The process involves using test instruments, sensors and monitors to verify proper temperatures, airflow, and other characteristics of the HVAC system. DBR is developing the specifications for the Operations/Family Resource Project, while Stridde Callins is developing the specifications for the three Instructional projects. A third-party inspection gives the district the validation that multiple firms are collaborating to give the district the most productive and efficient HVAC system. Bids were received March 10th and the committee evaluated them on March 19th.
