HIGH SCHOOLS Likes, Wishes & Questions



High Schools

LIKES:

- Relocating and rebuilding the Natatorium gives SWHS band their parking lot back
- Providing coaches and student-athletes better facilities
- Standardizing facilities
- Bringing more students into Athletics
- Updating all facilities is important
- Less cancelations because of turf
- More consistent practice schedule

QUESTIONS:

- With increased capacity can we offer more swim lessons/programs, etc.?
- Site issues/overlap parking?!
- We want the community to understand the number of studentathletes and users
- What happens to the natatorium if it doesn't pass but the High School proposition passes?
- Have there been considerations about the maintenance and operating costs/
- Were there multiple options considered? (Good, better, best)?
- Instructional pool?

Natatorium TABLE-TOP SHARE-OUT:

- Instructional pool would allow elementary and middle school students to have instructional swim program instead of using Dad's Club and YMCA.
- Practices now have to start at 5:30 a.m. and NHS has to swim at the YMCA, so they never get to practice in their competition pool.
- HVAC is aging and undersized. A/C was only added in '09 and didn't account for body heat of spectators.
- SBISD runs 2 PE swim programs (SPED and non-SPED). Instructional pool will get younger kids started earlier and develop water safety.
- What about maintenance costs for new Natatorium?
- Location should have ample parking.
- We could go without baseball field upgrades, but cannot go without a new Natatorium.

Athletics Complex (Tully & DCC) QUESTIONS:


- Why are we just moving the band?

- May help with second site for varsity football parking?


Grob Stadium


Which option would you like to see in a potential bond package for Reggie Grob Stadium?


