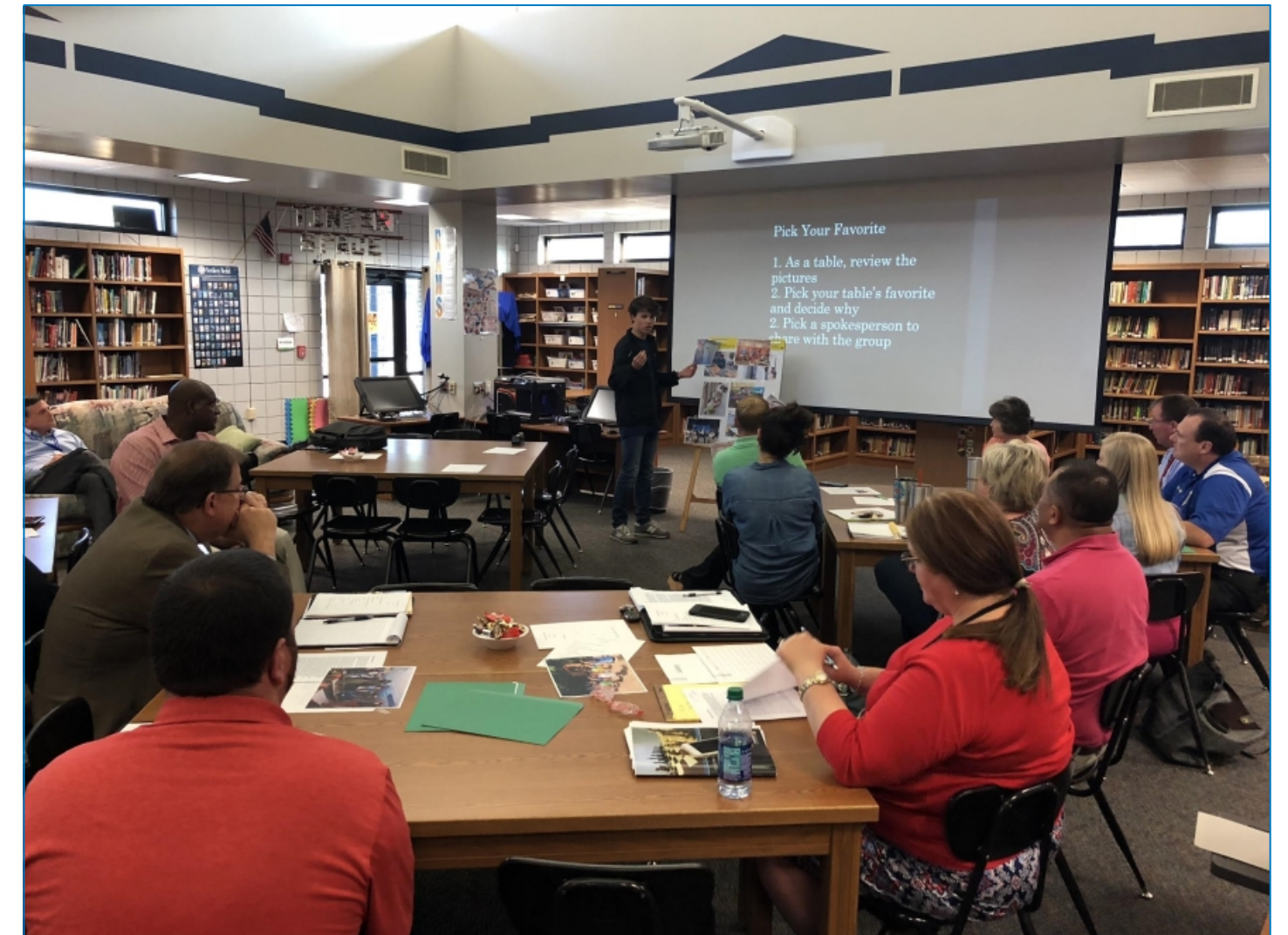
# Safety & Security: Strategic Plan

# Safety & Security: Leadership



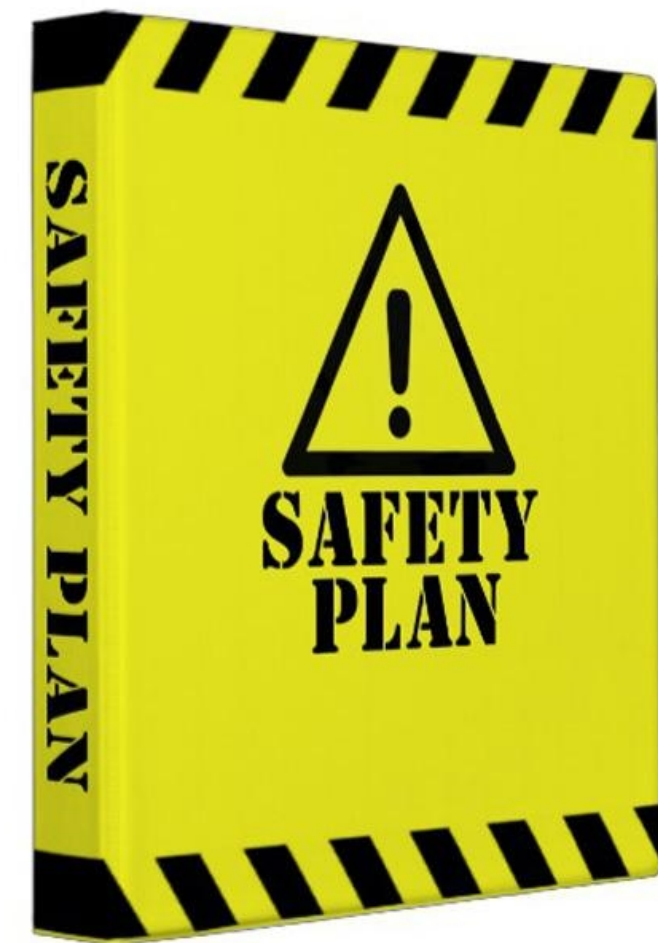

# Safety & Security: Now

## Current Procedures Include:

- Annual security check of all FSPS schools and buildings
- Assist law enforcement with campus threats
- District Crisis Team meets monthly/Campus Crisis Teams meet quarterly
- Mandatory Campus Drills for Evacuation, Fire, Lockdown and Tornado



# Safety & Security: Now

## Current Procedures Include:

- **Locate lost/missing students in coordination with law enforcement**
- **Loss Prevention Committee**
- **New Staff and Substitutes Fingerprinted via Arkansas State Police System**
- **Tornado shelters (23 - 1 at each elementary & junior high)**





# Safety & Security: Now

## Current Annual Expenditures Include:

- **Camera Upgrades/Replacement**
- **Raptor Campus Sex Offender Database**
- **“Secure Volunteer” Background Checks**  
on all Mentors & CSL Volunteers
- **School Resource Officers - 4**
- **Site expenditures, like light replacement  
and fence repair**

# Safety & Security: Proposed

**Included in current millage proposal:**

- **Alarm upgrades (fire/intrusion)**
- **Controlled access for all FSPS schools**
- **Exterior site lighting improvements at FSPS schools**
- **Secure entries for all FSPS schools**
- **Tornado shelters for high schools - two each**
- **Walls and doors for open classrooms at Barling, Cook, Morrison and Woods**
