- A. **Principals** The building principals will be in attendance to provide information in their respective reports.
- B. **Building and Transportation** Jeff Stauder will provide an overview of his report.
 - 1. **Consideration to purchase 2 Vans** Jeff Stauder will have some information on two vans that are available at Bob Ridings in Pana. Both are 2019 Dodge Grand Caravans with 60,000 miles. Both are a little high in mileage, but there is not much inventory to choose from and there is some uncertainty on what next year will bring. Jeff believes that both vans will be able to serve the District's needs for the foreseeable future and ESSER funds will be used to pay for them. They will replace 2004 and 2005 models with 220,000 miles on them. Both are currently priced at \$26,992 (for each vehicle).

Action: Motion to approve the purchase of two 2019 Dodge Grand Caravans from Bob Ridings in Pana for \$27,472 each, which includes title, vehicle registration, and documentary fee.
