Constraint #3:

**Allow any school to be rated as an F (Based on TEA A-F Ratings)
for more than one year without making progress on their
numeric overall score**



Background

2023 State Accountability Ratings still not released: The issuance of 2023 *A–F* ratings under the final 2023 rule is pending and subject to change based on judicial rulings or decisions from the legislature.

2024 State Accountability Ratings blocked: August 13, 2024 - Travis County Judge issued a restraining order blocking TEA from releasing ratings.

STAAR Interim Assessments



Utilized to monitor progress on overall numeric score for each campus from Fall 2023 to Fall 2024

- Align to the Texas Essential Knowledge and Skills (TEKS)
- Help educators monitor student progress
- Predict student performance on the spring STAAR.
- Provide data from which an overall numeric score can be calculated.

Secondary Schools

When comparing campus performance on last year's fall 2023 STAAR Interim Assessment with this year's fall 2024 Interim Assessment performance -

4 of 5 MISD secondary schools made progress.

Range: 12 percentage points to 23 percentage points

1 MISD secondary school remained constant.

No change in overall numeric score

Professional Development and Training for Teachers

- Big push in mathematics

- Structured literacy: explicit phonics instruction
- Meeting individual student learning needs
