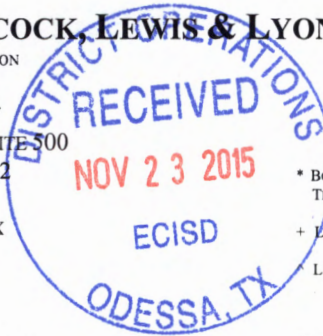


As have been our discussions for some time now, the City of Odessa is interested in the
