Dear Mr. Lefko,

This letter responds to your Illinois Freedom of Information Act ("FOIA") request received on October 9, 2025 seeking the following records:

- 1. Copies of any final arbitration awards, decisions, settlements, or summaries issued between January 1, 2023, and the present date.
- 2. Any board or administrative records describing the resolution or outcome of those arbitration cases.
- 3. Documents sufficient to identify the dates, arbitrator(s), and nature of the disputes, limited to what is necessary to understand the arbitration results.

The District is denying an arbitration award, briefs, correspondence describing the award or the underlying grievance, and the demand for arbitration, because the responsive records are exempt from disclosure under Illinois FOIA for the following reasons:

- The responsive records are categorically exempt pursuant to FOIA Section 7(1)(p), as they relate to a collective negotiating matter between the District and its employees' representative, and the records are not a final contract or agreement. See 5 ILCS 140/7(1)(p).
- The responsive records are categorically exempt pursuant to FOIA Section 7(1)(n), as they relate to a public body's adjudication of an employee grievance, and the case is not one in which discipline was imposed. 5 ILCS 140/7(1)(n).

I am the person responsible for the denial of your request. You may ask the Illinois Attorney General's Public Access Counselor (PAC) to review this decision concerning your records request, by submitting a Request for Review to the PAC by electronic mail or U.S. Mail within 60 days after this denial or partial denial of your request. A request for Review by the PAC should be directed to Public Access Bureau, Office of the Attorney General, 500 S. 2nd Street, Springfield, IL 62701, public.access@ilag.gov, 1-877-299-FOIA.
