Presentations/ Recognitions	Five public school administrators from across Texas were selected as state finalists for the annual Superintendent of the Year (SOTY) award. Sponsored by the Texas Association of School Boards (TASB), the SOTY program has recognized exemplary superintendents for excellence and achievement in educational leadership since 1984.
	Dr. Jamie Wilson was selected as one of the state's five finalists representing Region 11.
	Dr. Wilson was recognized for serving a diverse population of about 32,000 students. He has been in education administration for 19 years, serving as superintendent of Denton ISD for eight of those. The committee noted that Wilson leads this fast-growth district with a "can-do" attitude and a data-driven approach. Wilson places a priority on social and emotional learning and considers it an essential ingredient for academic success.
	The selection committee stated his focus on the whole student was evident during the pandemic, when the district worked first to meet the basic and emotional needs of students before addressing their learning needs. Wilson is

	an avid advocate for public education and ties district outcomes to legislative priorities. Wilson earned his bachelor's degree, master's degree, and doctorate from the University of North Texas.
	Candidates are chosen for their strong leadership skills, dedication to improving educational quality, ability to build effective employee relations, student performance, and commitment to public involvement in
COVID-19 Update	Dr. Matt Richardson, Denton County Health Department stated the Covid- 19 surge has arrived. Hospital capacity is declining and there were only 10 ICU beds available and it is very concerning. In July, our 7-day rolling average of percentage of total impatient beds was at 10.9% now on November 15 <sup>th</sup> the rolling average is at 14.3%. If this persists for 7 consecutive days or more the Governor could allow the County Judge to rollback openings of businesses and limit group gatherings, bars, restaurants and limiting possible elective surgeries.
	Susannah O'Bara provided an update for the Connected Learning enrollment and the 3 <sup>rd</sup> quarter timeline for Elementary campuses and how the District is continuing to support the needs of CL by campus.
	Dr. Gwen Perkins provided an update for the secondary Connected Learning and the plan to hire new CL teachers to assist for the remainder of the school year.

The plans are a working, living document that provides each campus a pathway for student success. Classroom Display and AV Refresh Update for Gonzalez School For Young Children	Robert Pierce updated the Board of Trustees on the Gonzalez School for Young Children's portion of the Classroom Display and A/V Refresh Project that was approved at the December 10, 2019 Board meeting. The funding for this project is from the 2018 bond package. During the investigations for this project, the Gonzalez SYC had non- interactive projectors in each classroom with an interactive touch panel on a rolling cart shared per pod. At the time, the most cost-efficient solution seemed to be to replace the non-interactive projectors with new projectors and keep the shared interactive, cart-based solution per pod. While preparing for the Promethean deployment for Gonzalez SYC, based on lessons learned in the deployments at other campuses, it became apparent that an interactive solution per classroom was really the best option.
Open Forum	This item is for information only. No action is required. These comments were provided virtually, and all Trustees were given copies of the submitted comments. Written comments were received from the following individuals: Chris Goodridge Tammy Sweeney Kerri Kennedy requested her comment to be read aloud. I am here tonight as a concerned parent and healthcare worker to request a harder look at the current COVID prevention practices in place at our schools. I have reached out twice at the school level and feel as though it has fallen on deaf ears. These recommendations do not increase the budget, do not require additional staff, and would decrease the likelihood of transmission of COVID. There are certain activities that fall into a "high risk" category to increase the transmission. These activities where people have to speak louder/project their voice, and increased respiratory output that could cause small particles of a person's breath to become airborne. All of our sporting events that I attend or see photos of show that DISD students are not appropriately masked or maintaining 6-foot distance during activities. Wearing a mask

when not able to be socially distanced can decrease the risk. Please consider the following:

1. Requiring our student-athletes to wear a mask in the weight rooms at all times. Students are exhaling forcefully with lifting weights and large groups are in there at once. Community gyms are currently mandated to require people to wear masks while working out. DISD does not meet the current standards set for by the Governor.

2. Requiring our cheerleaders to wear a mask while cheering. Remove megaphones. Cheerleaders are cheering without masks at games. MANY schools require cheerleaders to cheer the entire time with a mask on. They are projecting their voice with their cheers and are not socially distanced the entire time.

3. Requiring gators or masks on the sidelines of football, volleyball, and basketball games. I recognize that people have reservations while players are out on the field/court, however, a gator would be easy to wear and pull up on the sidelines and remove if needed to join the game quickly. Coaches are not consistently masked.

4. Require all teachers, office staff, coaches, and students to wear a facemask that conforms to their face. I have observed office staff with no masks, teachers and coaches wearing the clear mask that does not come over the nose or below the chin. (I recognize that the deaf Ed students need special accommodations, but this has been witnessed in non-Special Ed areas.

5. Increase communication to parents and students on the steps that DISD is taking to modify their current COVID plan as numbers of positive students increase across the district.

Thank you for taking this into consideration. I encourage DISD to reach out and get further assistance with risk assessments at your schools. We have many great resources here in Denton County that would be happy to assist in making our schools safer.
