2A. Superintendent's Report

- E. Policy <u>706 Acceptance Of Gifts</u> permits the school board to accept donations or gifts under the terms of the policy. **I recommend accepting the gifts as described on the enclosure.**
- 4. Truth and taxation information will be presented by Joe Prom, Director Of Business Services. I recommend approving the payable 2015 levy in the amount of \$7,584,281.
- 5. "MS 179.08 Subd. 2. Meet and confer. The professional employees shall select a representative to meet and confer with a representative or committee of the public employer on matters not specified under section 179A.03, subdivision 19, relating to the services being provided to the public. The public employer shall provide the facilities and set the time for these conferences to take place. The parties shall meet at least once every four months."
 - The process used by the district for meet and confer is depicted on the attached memo. The superintendent has served as the representative of The Becker School District (employer) since 2010. This practice complies with the statute, is consistent with policy governance, and reflects Policy 222, Board Superintendent Relationship: "The Board's direction of the operational organization will be

through the Superintendent who functions as the chief executive officer....The Superintendent is the Board's only link to the operational organization. Authority over and accountability of staff is the responsibility of the Superintendent.

- The meet and confer representative(s) can be appointed by the chair or by action of the board.
- 6. MS 123B.09, Subd. 5 provides that the school board shall fill a vacancy by appointment. If the vacancy occurs on or after the first day to file affidavits of candidacy for the school district general election, or when less than two years remain in the unexpired term, there shall be no special election to fill the vacancy and the appointed person shall serve the remainder of the unexpired term until a successor is elected and qualifies at the school district election.

At the November meeting, the school board decided to accept applications until November 24th at 4:00 p.m. The board also decided to determine how to proceed at the December 1st meeting. Applications were submitted by Curtis Head, Phil Norgaard, and Ryan Obermoller. The term will expire on the first Monday in January 2017. **The attached resolution should be used to appoint a school board member.**

7. <u>Policy 223 Strategic Goals</u> is the culmination of the school board's strategic planning this past year for the 2015-16 school year. The first reading was last month. **I recommend adopting the policy.**
