5. TRUTH IN TAXATION PRESENTATION, Gary Kawlewski

Levy will increase 2.61% or \$388,623. Taxes will start to be collected in May of 2019. 2018-19 revenues are projected at \$82,021,204 with expenditures at \$85,908,084. 83.71% of the district's revenues come from the state and 10.64% from local property taxes. Salaries and benefits make up 75.43% of the district's expenditures. State determines all revenue formulas, tax policy, maximum authorized property tax levy and approves whether school districts can submit referendums for operating and capital needs before the voters. As property value of the district increases, the state contribution decreases. Again refinanced the bonds for the Buffalo High School, this is the third time, lets us reduce taxes by \$96,942 for the next five years. Comparing us to area districts, we are 7th at \$811, in amount of tax impact on a \$200,000 home. STMA is the highest at \$1171 and Dassel-Cokato is the lowest at \$578. Board can accept public comments at tonight's presentation.

6. ACTION ITEMS

A. Certify 2018 Pay 2019 Levy, Gary Kawlewski, Director of Finance and Operations

Recommending the Board approve the 2018 Payable 2019 tax levy of \$15, 250,100.07. This is an increase of 2.61% or \$388,623 from the Pay 2018 levy. Many residential homestead valuations have increased which in turn has increased the referendum market value of the district by 7.06%.

Discussion: Special Ed funding changes – depends on the Legislature's budget next spring.
