6. Superintendent's Report

6.1 Legislative Updates:

Two Federal Grants Cancelled Which Support SPED Teachers and Deafblind Students:

The federal government has ended funding for the Wisconsin Deafblind Technical Assistance Project (WDBTAP) and the State Personnel Development Grant (SPDG), which were intended to help recruit and retain special education teachers. The WDBTAP, which serves 170 students with vision and hearing loss, provided assistive technology tools, coaching, family support, and professional training. The SPDG, which was part of a five-year grant cycle, funded programs like the Special Educator Induction Program, which supported 280 new special educators. The DPI plans to appeal the decision to end both grant programs. The loss of funding comes at a critical time for staffing shortages in Wisconsin and the nation.

8.1 Review of Board Calendar

President Burns reviewed the Board calendar.

8.2 Board Committee Reports:

8.2.1 Communication & Community Relations – Deal

Committee Chair Deal reported that the committee met on September 22, 2025. The committee discussed the district's strategy to make its website ADA compliant by the April 2026 deadline set by the Department of Justice, ensuring accessibility features like alt text, clear titles, and avoiding PDFs and graphics. Additionally, the committee agreed to change its name from Communications & Community Relations to Communications & Engagement to better reflect its purpose.

8.2.2 Financial Stability & Efficiency – Keyser

Committee Chair Keyser reported that the committee met on September 18, 2025. The committee discussed the district's focus on a new compensation model for certified staff, using a "We Not Me" steps-and-lanes approach. The Compensation Committee is gathering feedback through fall 2025, with plans to finalize materials by November and begin staff outreach. Key milestones include Board workshops, approval requests in early 2026, and a rollout of contracts by April. Additionally, an 11% health insurance renewal will be presented for Board approval tonight, and updates on post-65 retiree coverage are forthcoming, with a recommendation to fix district costs and set employee premiums at \$72.

8.2.3 Recreation & Community Services – Lee

Committee Chair Lee reported that the committee met on September 15, 2025. The committee received updates on staffing and compensation for before and after school care programs and is exploring options such as increased subsidies, new staffing models, fee adjustments, and possible outsourcing, with a full report to be presented to the Board. Additionally, updates were shared on athletic coach stipends, including revisions to align with current athletics, consideration of longevity pay to retain quality coaches, and support for a forthcoming district compensation recommendation.

8.3 Board Member Reports of Community Events:

- Ms. Carr attended the Nathan Hale homecoming parade, which was delightful and featured exceptional floats.
- Ms. Lee attended the Nathan Hale homecoming parade, which was awesome, and was pleased to see the senior football players participate in it, when they would usually be at practice.
- Mr. Becker attended several Nathan Hale football and volleyball games, as well as the open house, where he commended teachers' commitment to stay late to speak with parents and noted that the Carnegie math curriculum was cohesively presented and aligned with the recent Board committee report.
