Title:

2025 HBI Schools to Skills Grant Program

Administration Recommendation: It is recommended that the Board of Trustees approve the acceptance of \$5,650 from the Home Builders Institute (HBI).

Authority for this action:

Policy CDC (Local) states that any gift with a cost or market value of \$5,000 or more, any gift that the potential donor has expressly made conditional upon the district's use for a specified purpose, or any gift of real property, shall require Board approval.

Plan addressed:

The plan is to have up to two instructors trained to use Home Builders Institute's nationally recognized patented Pre-Apprenticeship Certificate Training (HBI PACT) curriculum. Plans are to certify students enrolled in the Principles of Construction Tech course in HBI PACT Core during their first year at Stratford High school. It is expected that programming will begin at the start of the Fall 2025 Academic Year or as soon as possible upon

completion of Instructor Training & Certification.

Background:

SBISD currently offers another industry-based certification to most, but not all of our students. The obstacle is that some of our instructors do not meet the qualification requirements to prepare students to obtain it. By implementing the HBI PACT curriculum, all of our program teachers will give ALL of their students the opportunity to obtain a certification. Because the HBI PACT Curriculum is 75% hands-on, the instructors predict that their students' certification pass rate will increase

tremendously.

Impact of this action:

If the grant award is approved, SBISD will implement the project. If the award is not approved, SBISD will evaluate funding options.

**Budget information:** 

The grant award of approximately \$5,650 will be used towards HBI PACT licensing as follows: Licensing Cost (initial year and renewal year, instructor training and certification for up to two teachers, and PACT Student Assessment Fees for a period not to exceed two years.

Monitoring and reporting timeline:

Primary data points to collect are: Student enrollment/class sizes,

student completion and certificate numbers.
